THE 1805 GEORGIA LAND LOTTERY

The Georgia Land Lotteries were created to distribute land in newly formed counties and to encourage settlement in these areas. There were six separate land lotteries. The first 3 lotteries (1805, 1807 and 1820) do not acknowledge military service. Only the last 3 (1821, 1827 and 1832) recognized Revolutionary soldiers or other military service.

The first lottery was created by an Act of the Legislature on May 11, 1803, for lots in parts of Baldwin, Wayne and Wilkinson counties. The drawing was held in 1805 and is generally known as the 1805 Land Lottery.

Lots offered in Baldwin and Wilkinson counties contained 202 1/2 acres with a grant fee of \$8.10 per Land Lot. Wayne County lots were 490 acres with grant fees of \$19.60.

Persons entitled to draw in the 1805 Lottery were:

Bachelor, 21 years or over, one-year residence in Georgia, and a citizen of the United States: 1 Draw

Married man, with wife and/or child, one-year residence in Georgia, and a citizen of the United States: 2 Draws

Widow with minor child, one-year residence in Georgia: 2 Draws

Minor orphan, or family of minor orphans, with father deceased and mother deceased or remarried: 1 Draw

THOMPSON MILL HISTORY

(The following article was printed in The Danielsville Monitor, Danielsville, Georgia, in 1978. It is reprinted by permission of Calvin G. Floyd.)

A two story house where Georgia Highway 172 crosses South Fork Broad River stands in tribute to the honor of Alexander Thompson, Sr. and his family. This house was completed in the year 1800 and is the oldest structure in the area. It is now owned and occupied by Willie Long and his wife, who take great pride in the upkeep of this historic place.

Alexander Thompson moved his family from Burke County, NC, to Wilkes County, Ga., in 1788. His sister and her husband, William McDaniel, also came to Wilkes County at this time.

James Thompson, Sr., eldest son of Alexander Thompson, Sr., moved from Wilkes County to a site on the west bank of South River in 1790. This was across the river from where the Thompson house now stands. A few months later Alexander Thompson, Sr., moved to a place on the east side of South River across the river from his son's home. This was in Elbert County at that time. They built substantial log houses for their families when they arrived at their new home sites.

Alexander Thompson, Sr. built a dam across South River at the shoals. A grist mill and a saw mill were constructed and were operated by water power. His will states that he also had cotton machines. In the book, Our Kin by Manning, it is written that this was the first grist mill in north Georgia. Lumber was sawed at the mill from primeval timber to build the two story home of Alexander Thompson, Sr. Houses were built for several members of his family also.

Esther and Alexander Thompson (Sr.) were born in Pennsylvania. They were the children of James "Jimmie" and Ruth Alexander Thompson. James "Jimmie" Thompson was the son of John and Esther Hale Thompson who lived in Ireland. John Thompson was the son of Captain Alexander Thompson who first lived in Scotland; and Capt. Alexander's father was also named Alexander. Capt. Alexander Thompson served in the Tyrone Rebellion (1595-1603) and was given a land grant in Ulster, Ireland, where he moved.

Jimmie Thompson was orphaned at age 10. He was bound to Patrick Hagan. Hagan was a very harsh taskmaster and made Jimmie do most of the farm work. Sundays were spent in religious study at the Hagan home.

Jimmie ran away from Hagan when he was 13. He crossed the sea into Scotland with a merchant friend. He met a John

Alexander who hired Jimmie to plow for him. The Alexanders were Presbyterians and they took Jimmie into their home and reared him. He was sent to his first formal school.

John Alexander had one child, a daughter Ruth. Jimmie fell in love with Ruth and they wanted to marry. Her parents did not allow this until Ruth was 18 and Jimmie 21. The John Alexander and James Thompson families emigrated from Scotland to America about the 1730's. They settled about 20 miles west of Philadelphia, Pennsylvania.

Alexander Thompson, Sr. was born 1739 and died 1815 in Madison County. He married Elizabeth Hodge (1745-1820). They are buried near Thompson's Mill, but no grave markers have been found by the writer.

Alexander Thompson, Sr. was a Revolutionary War soldier. He received a scalp wound at the battle of King's Mountain which left a permanent scar. He was on the first Superior Court Jury list after Madison County was formed in 1812. He was a member of the first Board of Road Commissioners from Danielsville District in 1812. He bought one of the lots at auction on the Court House Square in Danielsville, which were sold for funds to build a courthouse.

James Thompson, Sr., son of Alexander Thompson, was also a soldier in the Revolution. He served for 20 months and 21 days and was also at the Battle of King's Mountain. He was appointed by the Georgia Legislature to the Board of Madison County Academy in November 1812. He was on the first Superior Court Jury list in 1812 of Madison County.

A plantation of 1900 acres was operated by the Thompson family. Several slaves were owned by family members. The mills and farms were operated for several generations by descendants of Alexander Thompson.

Alexander Sr. and Elizabeth Hodge Thompson had 9 children. 1. James, Sr. m. Sarah Saye. 2. Ruth m. Henry Strickland (son of Solomon and Amy Pace Strickland). 3. Sarah m. David Robinson. 4. Esther m. William Langford. 5. Mary, who was killed in childhood by a falling tree. 6. John, never married. 7. Robert m. Nancy Saye, sister of Sarah. 8. Alexander, Jr. m. Eunice Strickland, sister of Henry (& daughter of Solomon and Amy Pace Strickland). 9. Will m. Nancy Tillman.

William and John Thompson inherited the mill and home tract from their parents. John never married and willed his interest to his brother, William. John died at Williamsburg, Virginia, during tumor surgery and William then became sole owner of Thompson's Mill and farm.

William (1781-1854) and Nancy Tillman (1784-1858) Thompson had 11 children. 1. John Alexander m. Eleanor Burroughs.

John was sheriff of Madison County for two terms. 2. William Tillman. 3. Ansel Dickson m. Mary Richards. 4. James Madison m. Diana Pellum. 5. Elizabeth Eleanor m. Amos Carithers. 6. Berry Millroy m. Amanda Jane Carithers. 7. Mary Farrow m. James W. Carithers. 8. Nancy Emily m. John A. McCurdy. 9. Harriett Calista m. Meritt Landers. 10. Sarah died in childhood. 11. Esther died in childhood. The Tillman family lineage is available to 1225. William and Nancy Thompson are buried at New Hope Presbyterian Church Cemetery.

Berry Millroy Thompson inherited the mills and farm from his father and operated these during his lifetime. About 1895 the old Thompson home was renovated by him. Several rooms were added and many improvements made. Wyt E. Thompson writes in 1905 that he was given some cut nails drawn from the old home which were made at the shop on the farm.

Berry M. Thompson attended Jefferson Medical College in Philadelphia, Pennsylvania, and the Medical College in Atlanta, Georgia. He was licensed to practice medicine in 1847, a profession he followed as long as he was physically able. Dr. Berry M. (1821-1906) and Amanda Jane (1830-1873) had 2 children. 1. William Hope (1868-1953). 2. Mary B. (1852-1899). Dr. Berry and Amanda Jane Thompson are buried at New Hope Presbyterian Church Cemetery.

William Hope Thompson inherited the mills and farm from his father and operated these for a number of years. He married (1) Aquilla Brown, and (2) Mrs. Jessie Lonnis Martin Phillips. William had 6 children; and he is buried at Waynesboro, Georgia.

The mill and farm properties passed from Thompson family ownership. Later, J. Will Gholston of Comer, Georgia, became the owner. Willie Long bought the part of the property which has the old Thompson home on it. He grew up a short distance away from the mill and farm. His family has also been a great part of the heritage of the area.

Only a very few ruins are left to mark the site of the mills and dam. Some of the houses of the Thompson children remain, but these are all in very bad condition.

Alexander Thompson, Sr. and Elizabeth Hodge Thompson are the progenitors of hundreds of descendants. The generations possible may extend to the 10th or 11th.

In the name of God, Amen. I ELISHA STRICKLAND of Wake County & State of North Carolina, being in perfect mind and memory, thanks be given unto God, calling into mind the mortality of my Body and knowing that it is appointed for all men once to Die, do make and ordain this my last Will and Testament. That is to principally & first of all I give and recommend my Soul into the hand of Almighty God that give it and my Body, I recommend to the Earth to be Buried in a decent Christian Burial at the discretion of my Executors nothing doubting but at the general resurrection, I shall receive the same again by the Almighty Power of God. And as touching such Worldly Estate where with it has been please God to bless me with in this Life, I give demise and dispose of the same in the following manner & form:

First, I to my Dearly beloved KENCHION STRICKLAND the manor Plantation where I now live containing by estimation 300 acres lying on both sides of Mockason Creek; one Negro woman named Hannah; one Negro girl named Vilet; & one Negro Boy named Croel; one Mare, Saddle & Bridle; one Bed & furniture & all my cattle but one cow & calf that I leave to my Grand Daughter Milbery STRICKLAND.

Also, I give to my son, ISAAC STRICKLAND, two hundred & fifty acres of land lying in the fork of Mockerson, It being the plantation where he now lives.

Also, I give to MARY CARTER one Cow & Calf.

Also, I give to my son, JACOB STRICKLAND, one shilling.

Also, give to my Daughter, PRISCILLA SEAGROVES, one shilling.

Also, I give to my Daughter, CHARITY JOHNSTON, one shilling.

Also, I give to my Daughter PATTY STRICKLAND, one Bound girl named SILVEY HICKMAN till she is twenty one years of age.

Also, I give to my Daughter, SALLY PACE, one Negro woman named Tims.

Also, I give to my above named grand Daughter, MILBERY STRICKLAND, one Negro woman named Nanny (only her third child to my son, ISAAC STRICKLAND) and one Bed,

To them to possess after my decease & the remainder of my land, Horses, Sheep & geese & all the rest of my living - I leave to be sold by son ISAAC STRICKLAND, whome I appoint to be my Executor to this my last Will and Testament as much as will pay by Debts & the rest I leave to my son KINCHEN & I do hereby

utterly disallow revoke & disannull all and every other former Testament, Wills, Legaces, bequest and Executors by me in any wise before named, willed and bequeathed, Ratifying & confirming this & no other to be my last will & testament. Witness whereof I have hereunto set my hand and Seal this twenty third day of February in the year of our Lord one Thousand Seven Hundred & Ninety five.
