Strickland Research, Inc. is a non-profit, tax-exempt family organization formed for the purpose of researching and compiling all available information on the Stricklands in America. By compiling all information on the various lines in one location, we hope to help family genealogists avoid duplications of research efforts.

Strickland Research, Inc. was established in January, 1980. Since that time, our organization has continued to grow, and, we are now represented by members in nearly every state in the Union. We are also fortunate to have members in Canada and Australia.

SRI has established a library containing the individual files of our members, Ancestor files, books and manuscripts pertaining to the Strickland family, and periodicals which are donated or exchanged. Any information contained in our library is available to members and can be xeroxed upon request. At present, we do not have facilities for loaning books or material by mail.

In 1982, SRI established a Research Fund for the purpose of hiring genealogists in areas inaccessible to most members. This fund will enable us to obtain records from all parts of the United States. It will also be used to obtain records from other countries when we have established a firm lineage in America.

SRI began the publication of a quarterly, STRICKLAND SCENE, in January, 1980. The purpose of this publication is to keep family genealogists informed of available records, and to supply members with abstracts of records and stories of the Strickland Family.

The work done by officers or members of our organization is strictly volunteer. No one is paid for jobs within the organization and most of our information and library material is donated by members. Since we are non-profit, any donations are, of course, tax-deductible.

Our Constitution states that if our organization should ever disband, our files and library would have to be placed in a similar non-profit organization, such as, another non-profit family organization, an archives or a genealogical library. They cannot become the property of one individual. This fact alone guarantees the protection and preservation of the work we are now doing.

Strickland Research, Inc. is interested in ALL the facts about ALL of our Strickland ancestors. We can use copies (xerox or original) of old letters, old diaries or journals, newspaper clippings, and photographs, as well as Bible records, cemetery surveys and abstracts from county records. We progress by sharing.

On Sunday, we met at the Century Airport Inn for our Luncheon and Meeting. Our speaker was the Vice President of Strickland Research, Inc., Freeman Strickland. Comments from our members indicate Freeman's talk was the most informative and most interesting that we have had so far. Freeman showed the significance of

The first door prize, a year's subscription to THE ARMCHAIR RESEARCHER, was won by Mrs. Lynn Jones. The second door prize, a year's subscription to THE SOUTHERN GENEALOGIST'S EXCHANGE QUARTERLY, was won by Mrs. Virginia S. Roberts. Both of the door prizes are genealogical quarterlies which are edited and published by Joel, and we deeply appreciate Joel's generosity.

Since our workshops were so successful last year, it was announced at the October meeting we would have them again this year. The 1983 workshops will be as follows:

I would like to thank one of our members, Evelyn Marshall, who spent many hours going through ancestor charts to make 4 x 6 index cards on each ancestor and place names and addresses of those who are researching each ancestor. These cards are helpful in putting people in touch with each other who are researching the same line. I would also like to thank Barbara Winge for the many, beautifully typed 3 x 5 index cards (reference cards on individual Stricklands) for our county and state index file.

Page 58 - JACOB STRICKLAND, soldier, 7th US Infantry Regiment, executed Sat., May 31, 1828, on conviction of murder of George DECON at Cantonment Gibson. (Arkansas Gazette, June 4, 1828)

Page 66 - George DECON, Pvt., US Army, killed 1828.

(Note from Sharon Primeau: Can't help wondering if Andrew Scott called Gen. Hogan out over the death of Jacob Strickland, since the duel was on same day as execution.)

## JOHN STRICKLAND OF LONG ISLAND AND HIS SONS-IN-LAW

An article titled "John Strickland Of Long Island And His Sons-In-Law" by Herbert F. Smith of Washington, DC, which appeared in The American Genealogist Magazine (Vol. XI, pp. 81-87), gives a thorough study of the Last Will and Testament of John STRICKLAND and a short sketch of "The Career of John Strickland." According to Mr. Smith, both the original of this will and the "official" copy, probated in Jamaica, Long Island, NY, are in the Hall of Records in New York City.

Mr. Smith includes a transcription of the original will and a transcription of the official copy to show that the abstract of John Strickland's will which appears in the COLLECTIONS OF THE NEW YORK HISTORICAL SOCIETY for 1892 (p. 26: "Abstracts of Wills on File in the Surrogate's Office, City of New York, Volume I, 1665-1707") is quite incorrect. He states, "the original is quite legibly written, in fact almost printed." The transcription of the original will, offered by Mr. Smith, is as follows:

The Testam<sup>t</sup> of M<sup>r</sup> Jno. Sticklin  
Septimber th: 5: 1672

The Last will of M<sup>r</sup> John Stiklin as followeth

Being in great payn yet through gods mercy perfict in Sencis doe now Comit my body to the ground and my Soule to god that gaue (The e is so close to the letter preceding that it is difficult to tell whether it is a v or a u.) it and for my esteat I doe dispos of it as followeth that out of my esteat first all dewes & debt bee fully satisfied and for the Remainer: first that I doe give to my daughter Loum ( or Loam. The doubtful letter resembles an incompletely closed a; from other parts of the will we conclude it to be Loum, rather than Loam.) ten pound 2ly to my daughter matthews youngst child forty shillings 3ly I doe give to Jonathan mills on Cow (The words JONATHAN MILLS ON COW written over an erasure.) 4ly I doe give to John Loums eldest daughter on Cow and for the Remainer of my my Esteat I doe give to all my grandchildren to be devided eaquely among them that is to say those Childrin that have Bin borne of my daughters and are now Liveing and that this my will may be trewly performd I doe make chouce of my Sonn John Smith my Sonn Samuell Matthews John foster & Beniemin Coe as my exsecuters and that this is my Last will & testament I doe own by subscribing my hand the day and date above written

Jo(?)... S(?)... (The J is (well written; the rest, after making a couple of small loops, straightens and becomes indefinable.)

It is to be understood that thos two Cows mentioned to John Loums daughter & to Jonathan Mills ware my wives and shee gave them as shee saw good and I promising her to performe her will have accordingly disposed of them

Benjamin Coe

(NOTE: The parenthesis inserted in the above transcription were printed as footnotes in Herbert Smith's article.)

Recorded at the end of the "official" copy of the will is: This Will prov'd in Court of Sessions at Jamaica December 13th 1672. Two coves in Jonathan Mills his hands. One Cow in Samuel Matthews hands. In John Westcoats hands for Henry Howard 2 £ 10 s 00 d. Letters of Administration of the Estate of M<sup>r</sup> John Sticklin of Jamaica granted unto his Sonn in Law M<sup>r</sup> Jno. Smith one of ye Executoes.

Mr. Smith states, "The substance of the original will is that Mr. John "Sticklin," then a resident of Jamaica, New York, on September 5, 1672, caused his will to be made; and the disposal of his estate was either directly made to the following or to their heirs:

1. A daughter, who married John Loum.
2. A daughter, who married Samuel Matthews.
3. Jonathan Mills.
4. A daughter, who married John Smith.

Another heir of the estate was Henry Howard, according to a short account at the end of the official copy. The foregoing are the sole heirs mentioned in the will."

The second section of this article lists records on which JOHN STRICKLAND appears. The following is abstracted from Mr. Smith's article:

HISTORY OF CHARLESTOWN, MASS. (1845) by Richard Frothingham

- p. 20: first settlers 1628-9 included John STICKLINE  
p. 23: Simon HOYTE & John STICKLINE were admitted freemen in 1631.

NEW ENGLAND HISTORICAL AND GENEALOGICAL REGISTER, III

- p. 90: "Seargent STRICKLAND" took oath to become a freeman at a General Court held in Boston, May 18, 1631.

EARLY HISTORY OF WATERTOWN, VOL. II

- p. 113: John WHITNEY of Watertown, Mass., purchased 16 acres which had been granted to John STRICKLAND. John STRICKLAND was dismissed from the Watertown Church, May 29, 1635, and was among those who left Watertown to aid in the founding of a new settlement, Wethersfield, on the Connecticut River.

COLONIAL RECORDS OF CONNECTICUT, VOL. I

- p. 2: first meeting of magistrates of new colony, April 26, 1636, shows STICKLAND and others had formed a new church on the Connecticut River.  
p. 6: November 1, 1636 - payment to Sgt. STICKLAND for service "to the Rivers mouth."

HISTORY OF ANCIENT WETHERSFIELD, by Adams & Stiles, Vol. 1:

- p. 303: John STRICKLAND sold his Wethersfield, Conn., property March 28, 1640.

COLONIAL RECORDS OF CONNECTICUT, VOL. I:

- p. 466: Will of William FROST of Fairfield "made Jan. 6, 1644-5" refers to land he bought for his son, Abraham, from John STICKLIN.

According to Mr. Smith, "The record of John Strickland (Sticklin) begins on Long Island apparently in 1644 when he was a Patentee of Hempstead, New York, with others. He appears in Hempstead for about fourteen years until 1659...He was a resident of Huntington, NY, by 1660; on March 2, 1663, the Huntington records call him of Jamaica."

Several records mention John STICKLEN (Stiklings/ Stickline/ Stricklon) and his son-in-law John LUM. He sold his land in Huntington and moved to Jamaica where he died "between September 5 and December 13, 1672."

Mr. Smith states he does not agree with other publications which support the idea John had sons. "There is no immediate proof that John had sons."

(NOTE: Strickland Research, Inc., offers the above as a possibility of the lineage of John Strickland, but does not necessarily offer it as absolute proof.)

#### PENNSYLVANIA STRICKLERS

The following information is from the Strickland Library Card File. This index card file contains miscellaneous information on Stricklands who lived in various states. Information on these cards was obtained from printed sources, county records, and numerous other sources.

##### A. H. STRICKLER

Lived on Main Street in Mt. Pleasant, Westmoreland County, PA, in 1867. His house was the fourth house west of the intersection of Main Street and Church Street. (Reference: ATLAS OF WESTMORELAND COUNTY PENNSYLVANIA, published 1867 by A. Pomeroy; reprinted 1981 by Thomas J. Metzgar, R. D. 2 Box 159, Export, PA 15632)

##### I. STRICKLER

Lived in southeastern corner of the township of South Huntingdon, Westmoreland County, PA, in 1867. His home was located near the boundary line of East Huntingdon and South Huntingdon. (Ref: same as above)

##### J. STRICKLER

In 1867, lived in the southeastern corner of the township of South Huntingdon, Westmoreland County, PA. His home was located on Meadow Run near Jacob's Creek. (Ref: same as above)

##### J. STRICKLER

Two "J." Stricklers were living less than a mile apart in Unity township near Youngstown, PA (Westmoreland County), in 1867. (Ref: same as above)

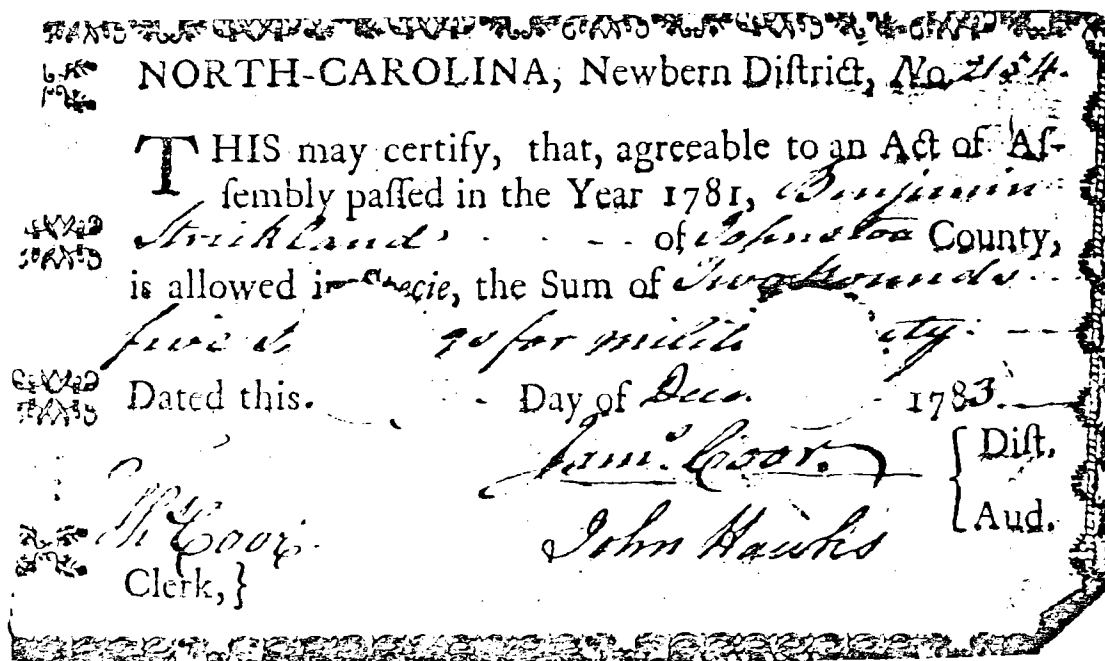
CERTIFICATES OF PAYMENT TO STRICKLANDS  
FOR MILITARY SERVICE OR GOODS USED DURING REVOLUTION IN NC

Contributed by Freeman Strickland

(Original certificates located in North Carolina Archives)

In August 1775, six military districts were set up by the North Carolina Provincial Congress to oversee the setting up of the organization, training and payment of minute men and militia. Initially, each district would organize one battalion of 10 companies with each company consisting of fifty men. The minute men would be regulated by the district, while the militia would be regulated by each county. The creation of new counties and the course of the Revolutionary War made for changes in organization and the number of men under arms at any one time.

The following is an example of the certificates, most of which were too dark to print. The holes in the paper are cancellation holes which were punched in the paper. Unfortunately, some of the cancellation holes cut away parts of names. The list below is an abstract of the information on each certificate.

STRICKLAND LETTERS FROM THE FILES OF VIRGINIA STRICKLAND ROBERTS

Alpharetta, Ga.  
May 4th 1938

Dear Miss Strickland,

I was glad to know you were going to write the Strickland History. My Grandfather's name was JOHN WM. STRICKLAND. Married Miss ANNIE FIELDS. To that union, 9 boys and one girl who passed away at the age of 19 yr. To the best of me knowledge he was a decendent of Scotland, he & 4 brothers - Lived in Anderson Co., S.C. Died in the Civil War. My grandmother lived a widow 40 yr.

My Father was J. A. STRICKLAND. Married Miss LUCINDA BROCK. 13 Children, 9 girls & 4 Boys. Girls: ELCANZIA, ESSIE, GENA, EULA married Mr. WILL KING 1st Lieutenant in Spanish War resides in S.C. on his farm in a quaint Brick home - ANNIE, ALMEDA, SELMA. Boys: DUDLEY, GROVER CLEVELAND, JOSEPH JR., Baby Strickland died in infancy. My Dady was county supervisor of Anderson Co. 26 yr. my best recolation. I was almost 22 yrs of age when I came to Ga. Married (Miss) LUCINDA CAROLYN FIELDS, daughter of Mr. J. F. FIELDS of S. C. We had 5 children to bless our home, 4 girls, 1 Boy. ALMA married LUTHER MCFARLAND, 1 child, he was killed by a street car. She is married to JOHN MCCLEREATH living at Fairburn Ga. SELMA married CANDLER HYDE at the age of 14 yrs. She was an invalid for 14 yr 4 mo & 16 da, died with T. B. They having 3 children in their home. MARION 24 yr. died pneumonia - Little ANNIE 5 yrs. passed away - Little RUBY who passed away at the age of 1 yr. The oldest girl is all the child we have living. I was borned Feb. 26, 1866. I am 72 yrs, have had a strokes of paralysis but thank the Lord I work some yet. I have lived in Forsyth & on the Line of Old Milton Co. 56 yr. I have never accumulated wealth because I spent so much Dr. Bills. Never held any office, only Baliff till I grew tired & resigned. My wife was borned Nov. 30, 1862. She is a perfect wife, almost Blind & Deaf. We are living in a 3 room house by our selves.

Mr. RILEY STRICKLAND lives at Roswell R#. Mr. JAKE STRICKLAND, a diferent family not related, who can give you their history. Send Mr. JAPER c/o Mr. W. S. OWENS, Roswell Ga. Our family Bible has got destroyed of the Older family. Hoping you success with your book. I have a request to make of you. I want a book.

## STRICKLAND CONFEDERATE VETERANS IN GEORGIA

Atlanta Journal, January 30, 1931:

MR. J. H. STRICKLAND, CONFEDERATE VETERAN, BURIED AT WAYCROSS Waycross, GA, Jan. 30.- Mr. JACKSON H. STRICKLAND, 84, pioneer of this section, one of the most beloved south Georgia survivors of the War Between the States, died here Wednesday night at the home of his daughter, Mrs. J. H. HARRIS, following an illness of two weeks.

Last rites were held Thursday afternoon at Mount Pleasant Church, conducted by the Rev. Mr. Fowler, pastor, and interment was at Mount Pleasant Cemetery.

He is survived by four sons, BANNER L. STRICKLAND and JOHN STRICKLAND, of Waycross; JOHN F. STRICKLAND, of Fairfax, and OTTIS STRICKLAND, of Jacksonville, Fla., and two daughters, Mrs. W. E. KING, of Telmore, and Mrs. J. H. HARRIS, of Waycross; also five brothers, C. STRICKLAND and JOHN STRICKLAND, of Perry, Fla., J. H. STRICKLAND and FALCON STRICKLAND, of Live Oak, Fla., and N. W. STRICKLAND, of Fort Myers, Fla.; and two sisters, Mrs. SALONA DAVIS, of Day, Fla., and Mrs. IOLA DIXON, of Jennings, Fla.

Atlanta Constitution, February 25, 1922:

MRS. W. M. STRICKLAND. Lyerly, Ga., February 24.- (Special.)- Mrs. W. M. STRICKLAND, aged about 75 years, passed away at the home of her daughter, Mrs. J. L. WYATT, in LaFayette, early Thursday morning, following an illness of only a few weeks. Mr. and Mrs. STRICKLAND formerly lived in this county, and had spent some time here during the past year with their daughter before their removal to LaFayette the first of the year. They have a number of relatives here.

Mrs. STRICKLAND is survived by her husband, who is an old confederate soldier; two sons, KNOX and JOHN STRICKLAND, of Villanow, Ga.; two daughters, Mrs. MINNIE POPE and Mrs. J. L. WYATT, of LaFayette.

The body was carried to Duluth, Ga., for funeral and interment.

Atlanta Journal, December 14, 1922:

MR. W. M. STRICKLAND DEAD. Duluth, Ga., Dec. 12.- The funeral of Mr. W. M. STRICKLAND, a Confederate veteran, seventy-seven years of age, of LaFayette, Ga., was held at the Methodist church here Sunday afternoon at two o'clock, the Rev. Firley Baum, pastor of the Presbyterian church, conducting the services. Interment was in Duluth cemetery.

Mr. STRICKLAND is survived by two sons and two daughters, Mrs. DOLET ALLEN, Feriday, Miss., Mrs. MARY WYATT, LaFayette; KNOX and JOHN STRICKLAND, LaFayette.

## Methodist's Tombstone Straightened

by Doug Freeland, Post Reporter

When Isaac Lemuel Gillespie Strickland observes the Methodists' bicentennial from the vantage of his tombstone, his view will not be slanted.

The 5½-foot marble marker to a founder of the Methodist Church in Texas has finally been righted in Columbia Cemetery in West Columbia after leaning progressively for a quarter of a century, with the prospect of a ignominious collapse.

The job was done Tuesday through efforts of Nell Tucker of Belaire, who has researched Strickland's all-too-brief ministry in Texas and who wanted to be sure the grave was repaired by 1984, the year of the national church bicentennial.

It also was accomplished through the work of concerned Methodists who collected \$600 in unsolicited donations.

Tucker's research shows the tombstone was brought to Texas by boat and ox cart from Tennessee in 1849. In nearly perfect condition today, it began to lean only after it was transferred to its present location.

Tucker figured it was tilting about 23 degrees before it was straightened. The project involved leveling the base and pouring concrete beneath it to keep it level.

At this point, Tucker said, the base dropped on the arch of her left foot and broke some bones.

A pink marble marker with a bronze plaque was set at the grave, the tombstone was scrubbed and its lettering was embedded with gold. Two errors were corrected: Strickland's initials were wrong on the original inscription, which also gave the wrong year of his death.

"It's beautiful, just beautiful," Tucker said, reflecting on the work as she recuperated at home. She credited the design of the restoration to Annie E. Luce, general manager of Restwood Memorial Park at Lake Jackson, and her son, Jay Bart Luce, her assistant.

Strickland was born in Kentucky and came to Texas in 1838, working on various Methodist projects in Huntsville, Houston and other communities in this area. He died in 1839 at the age of 30. Tucker thinks his death was caused by yellow fever.

During the illness, Strickland was nursed by his friend, Mrs.



Josiah H. Bell, who had recently become a widow. He was buried in the Bell family plot in West Columbia. In 1947, the body was moved to a chapel in the area that had been named after Strickland.

In October 1958, the grave was moved to Columbia Cemetery, which had been given to the community by the Bell family.

## ELISHA STRICKLAND'S WILL, WAKE COUNTY, NC

A typed copy of the will of Elisha Strickland of Wake County, North Carolina, was printed in Strickland Scene, Volume 2 No. 1, page 19 & 20. This typed copy was taken from the will recorded in Wake County Will Book D (p. 173).

The clerk's copy of Elisha's will (as recorded in Will Book D) shows the first item bequeathed as "First, I to my Dearly beloved KENCHION STRICKLAND the manor Plantation where I now live..."

A query was also printed in Strickland Scene, Vol. 2 No. 1, offering a theory that KENCHION STRICKLAND might be Elisha's wife.

In response to the printed query and will, Freeman Strickland went to the North Carolina Archives to search for pertinent information on Elisha's wife. His search uncovered the original will of ELISHA STRICKLAND which was brought into court, was proven to be the will of Elisha, and was duly recorded (copied) into Will Book D by the county clerk.

In copying the will, the clerk unintentionally omitted two very important words - "give" and "son." According to the original will which was brought into court, the first item bequeathed should read, "First, I give to my dearly beloved son Kinchen Strickland..."

This does not alter the fact that Elisha's wife could have been named Kenchion (or Kinchen), but it does prove that Elisha's wife died before February 1795, the date Elisha signed his will. Perhaps, with a little more searching, we can locate something that will help prove the name of Elisha's wife.

Many of the North Carolina wills, which were brought into court to be proven and recorded, have been preserved and are now kept in the North Carolina Archives. In so many cases and in so many states, the original wills (or "loose papers" as they are often called) have been lost or destroyed, so the only will we can refer to is the clerk's copy in the county book. Clerks were often overworked or careless and made mistakes which are difficult for us to discern or detect. In the case of Elisha Strickland's will, the clerk waited almost two years before recording it in the Wake County Will Book. Elisha's will was brought into court in September 1795, but not recorded until June 16, 1797. If the clerk had a backlog of two years work to record in the county book, it is understandable how errors could be made--especially with a quill pen!
