FINDS SISTER AFTER SIXTY YEARS

Frontier Times, 1926

A story, not without its thrills, pathos and keen human interest is told by the Rev. J. M. STRICKLAND of Alvin, Texas. The occasion for the incident being related at this time is the fact that recently he found his sister, Mrs. MARY E. FORSYTH, at San Diego, Cal., whom he had not seen or heard of in sixty years, and whom he supposed was long since dead.

It was in the turbulent days of the early '60's when a band of bushwhackers, under the cover of darkness, took the father of a family of ten children from their home near Cane Hill, Ark., and killed him at Fort Smith. The mother languished in illness for a month after the death of the husband and father, then passed into the great beyond. One child died before the children, driven by want, were forced to leave their home. They went to the home of their uncle, WILLIAM LAND, or rather to the home of his wife, for he was away in the army and soon died in a hospital at Fort Smith, and left his wife and two children. The widow bravely faced the world with eleven mouths to feed. Production was at a standstill in the South. Only a few old men, women and a multitude of children were left. Hunger stalked abroad in the land, and with hunger came disease and death.

At this time the Rev. Mr. STRICKLAND was about 9 years old. He recalls an incident of that period that is remarkable of the pathos and tragedy. One of his brothers 13 years old, contracted pneumonia from exposure, by reason of being undernourished and scantily clad, and died. Women fashioned a crude pine box and placed the body therein. They placed the improvised coffin on a homemade slide, hitched a pony to it and J. M. STRICKLAND rode the pony as it pulled the body of his brother to the grave. It does not require a vivid imagination to picture the tragedy and the heartaches of those little children as they followed the strange funeral procession across the bleak hills of Arkansas on a cold winter day. The women and older children lowered the body into the grave and heaped up a mound.

The children remained with Mrs. WILLIAM LAND in Scott County about two and a half years, and finally were reduced to a condition bordering on starvation, as were many near the close of the war. Northern Arkansas was more or less neutral territory during the war, lying between the opposing armies. The government established orphanages, or refuge homes, one of these being at Fort Smith. A northern preacher named SPRINGER was placed in charge of this home and the government fed the inmates. It was to this sanctuary that five women and twenty-one children made their way in 1865 and in the party was Mrs. LAND and her two children and the remaining ones of the ten STRICKLAND orphans.

The party started out with a small yoke of oxen, driven to an old wagon, and most of them walked. The distance was forty-six miles, and they had no food and but little money. Hogs were plentiful in the hills of Arkansas, and during the six days required to make the journey they killed three hogs, which were eaten without bread or salt. The Rev. Mr. STRICKLAND said they cut the meat into strips and roasted it over camp fires, each one roasting his own meat on the end of a sharpened stick.

Before reaching Fort Smith the steers gave out and they abandoned the wagon, driving the steers before them into town.

The military orphanage over which the Rev. Mr. SPRINGER presided was a large residence, the Lathan house, the owner being absent. Mrs. LAND and the children stayed there about a year, working at whatever came to hand for their sustenance. The Rev. Mr. STRICKLAND, now perhaps 91 years old, worked in the commissary, issuing food. Three of the STRICKLAND children died of measles during an epidemic. At the end of the year, the war being over, the refugees went North. Many of them rebelled, among them the children of the STRICKLAND and LAND families. They left the orphanage and made their way as best they could, there being only four of the ten who survived the war period, three boys and a girl.

Shortly after leaving the orphanage, the only girl, MARY ELIZABETH STRICKLAND then sixteen years old, married and moved with her husband to Kansas. Her brothers heard from her for about two months, then they became scattered and lost and never heard of each other again. Sixty years passed and now the remaining members of the scattered family are about to be reunited.

It was by the merest chance that Mr. STRICKLAND heard of his sister's whereabouts. His son, the Rev. W. A. STRICKLAND, was pastor of the Baptist Church at Balko, Ok., (now of Alvin, Texas), and the Rev. J. LAND was pastor at the neighboring town, Forgan, Ok. His father died at Fort Bayard, N. M. He went to attend the funeral and met a daughter of Mr. STRICKLAND's sister, who lived at Fort Bayard. Mr. LAND knew something of the history of the STRICKLAND family. Mr. STRICKLAND's sister of course, knew the history of her mother. She wrote to her brother and they confirmed the relationship.

Mr. STRICKLAND said his sister is the mother of eleven children and has twenty grandchildren and three great-grandchildren. She was born in 1850 and he in 1853. The other and remaining brother is G. W. STRICKLAND of Gravitt, Ark., who formerly lived three miles southeast of southeast De Leon for a number of years. The third brother died in Texas about fifteen years ago.

Mr. STRICKLAND is a staunch old pioneer of Comanche County. He came to Texas when 22 years old, making the journey with horse and wagon. He married before leaving Arkansas and brought his young wife and one child across the prairies to make their home in what virtually was a wilderness. Eighteen days were required to make the trip. He settled on the Scott farm, on Coperas Creek about eight miles from De Leon, although there was no De Leon for some years after he came. Comanche was a mere village in 1875, when he landed there, and there was no railroad west of Fort Worth. There was a store at Hazeldell and a couple at Sipe Springs in 1875, he said, and the only churches in the county were at Van Dyke and South Leon. The last Indian raid in the county was made in 1873, he said, the redskins killing a man named LESLIE, between De Leon and Comanche. De Leon was founded about 1878, and the railroad reached here about 1880.

Mr. STRICKLAND has been a student and minister for many years, his pioneer ministry doubtless contributing in large measure to the molding of ideals of good citizenship and of laying broad and deep the structures of religious faith which characterizes those of his denomination throughout that section. It is said that a man's religion should begin at home. This must be true in his case, as two of his seven sons have followed his worthy example and are active in the Baptist ministry, and one is an evangelistic singer.

We deeply appreciate Western Publications' permission to print this article in our quarterly. If any of you have additional information on J. M. STRICKLAND and other members of his family, please share it with us. We hope articles such as this will aid some of our members in locating their STRICKLAND ancestors. -NJC.

WARREN L. STRICKLAND, CONFEDERATE SOLDIER

WARREN L. STRICKLAND enlisted as a Private in Capt. John W. Wilson's Company of Cavalry ("Wood County Rebels") on August 5, 1861. This company subsequently became Company B, 10th Regiment Texas Cavalely. He was appointed 1st Sergeant on the 8th of May, 1862. He was wounded through both thighs in the Battle of Murfreesboro on December 31, 1862, and was discharged due to "disability from rounds received in battle."

His discharge papers give the following information: (Paper dated 6 May 1863)
30 years old; 6 ft. 1 1/2 in.; fair complexion; dark eyes; dark hair; farmer;
born in Coweta County, Georgia. Residence: Black Oak, Hopkins County, Texas.

ROBERT H. HIGGINBOTHAM AND EMILY STRICKLAND
OF YAZOO CITY, MISSISSIPPI

Note: EMILY STRICKLAND, daughter of Solomon & Amy Pace STRICKLAND, was born ca. 1784 in NC. About 1804 (GA), she married ROBERT H. HIGGINBOTHAM, son of Caleb & Mary Ann Cash HIGGINBOTHAM. Emily and Robert moved to MS where Robert died on 18 September 1831 and Emily died the latter part of 1840.

YAZOO CITY, MS COURTHOUSE, YAZOO COUNTY, MS; Probate Box 41:

State of Miss.) To the Hon. THO. B. WOODWARD Judge of Probate for said
Yazoo Co.) County. The late ROBT. H. HIGGINBOTHAM died in the month
of September in the year 1831, having both personal and
real estate. His son, HENRY HIGGINBOTHAM, obtained letters of Administration
with the will annexed, and, under an order of the Court proceeded to sell the
personal estate of the said deceased on the 28th day of March 1832 - The
whole of said sale amounted to \$4188.37. EMILY HIGGINBOTHAM, the widow of the
deceased being the purchaser. She gave her note for the amt. at nine months,
but never paid a single dollar of it. Things went on this way; the heirs being
all satisfied to indulge the old lady until the year 1835, when the said Ad-
ministrator left the state, and has never returned. There was now no adminis-
trator to demand payment, and none was appointed until after the death of the
said EMILY HIGGINBOTHAM which took place in the latter part of the year 1840.
The records of the Court will show that after her death I became administrator
of her estate as well as the estate of R. H. HIGGINBOTHAM (of the latter de
bonis non). Your honor will percieve from this _____ that as Administrator
of EMILY HIGGINBOTHAM, I must pay to the estate of R. H. HIGGINBOTHAM the amount
due as above stated and will have no difficulty in understanding the items in
my account as administrator of the former which state that certain sums have
been paid to the estate of the latter; and the corresponding items in my ac-
count as Administrator of the latter, which state that certain sums have been
_____ from the estate of the former. In my final settlement I shall not only
present an account current between myself and each of these estates; but also
an account current between the two estates. In this account the note of EMILY
HIGGINBOTHAM will be filed as a voucher. The latter part of the third article
of the last will of the said R. H. HIGGINBOTHAM orders that the proceeds of
his real estate should be appropriated to support and education of his minor
heirs. Under this clause I was anxious to have a fund set apart by the Court
for the education of THOMAS T. and ROBT. J. HIGGINBOTHAM the two youngest
children of the said R. H. HIGGINBOTHAM and both being minors; but in a con-
versation with your predessessor, he told me to go on and send them to school
and the Court would allow it in settlement. I accordingly did so; and this
will explain to you the manner of all my expenditures as Administrator of
R. H. HIGGINBOTHAM's estate for the support and education of said boys. Hoping
this explanation will be sufficiently clear and praying your honor to allow my
said account, I have the honor to be-

STRICKLAND FAMILY OF JASPER & CLAYTON COUNTIES, GEORGIA

The following family history was compiled by Strickland Research, Inc., for inclusion in CLAYTON COUNTY FAMILIES - YESTERDAY & TODAY.

I. ISAAC STRICKLAND: The earliest record of ISAAC STRICKLAND in Georgia is in 1812. ISAAC was a resident of old Randolph County (now Jasper County) when he bought land from DAVID ALLEN in Randolph (Jasper) County on the 4th of February 1812. The land he purchased was Lot #216 which was previously drawn as Baldwin County land by ELIJAH DAVIS of Washington County, Georgia.

The 1820 Census of Jasper County shows ISAAC as age 45 or over. A female, presumably his wife, is shown as 45 or over; and his children's ages are: two males under 10; three males aged 10 to 16; one female 10 to 16; and one female 16 to 26.

ISAAC drew land in the 1820 Georgia Land Lottery as a resident of Jasper County. The land he drew was Lot #209, Section 20 of Early County. An ISAAC STRICKLAND also drew in the 1832 Gold Land Lottery, as a resident of Jasper County. It is believed ISAAC died between 1832 and 1840 in Jasper County, Georgia; though some family researchers believe he moved to Chambers County, Alabama.

The 1830 Census of Jasper gives ISAAC's age as 60 to 70, and a female (his wife?) 50 or over. Their daughters were no longer with them, but two sons are listed as: one, age 10 to 15; and one, age 15 to 20. There were three Strickland brides in Jasper County from 1820 to 1827, any two of whom may have been ISAAC's daughters. They were: SALLY who married JAMES WHALEY on the 7th of December 1820; ELIZABETH who married HENRY BARRON on the 12th of June 1821; and NANCY who married JEREMIAH FARR on the 1st of February 1827.

ISAAC's sons were:

(1) CARY who was living in Upson County, Georgia, in 1830.¹ He was 20 to 30 years old and had one male 15 to 20 (possibly his brother, KINCHEN); and one female, 15 to 20, living with him. In 1832, CARY drew land in the Gold Land Lottery of Georgia as a resident of Upson County. On March 23, 1826, CARY married SARAH HANSFORD in Upson County. The 1850 Pike County Census shows him as 46 years old (born in NC). His wife (43 yrs.) was born in Georgia. With them are: SARAH, 17 (possibly a daughter by a previous marriage); GEORGE, 12; MARY, 11; NANCY, 8; CARY, 6; MILZA, 4; and MARTHA, 2.

CARY enlisted as a private in Company G 27th Regiment Georgia Volunteer Infantry, CSA, on September 9, 1861. This company was known as the "County Line Guards" from Pike and Spalding Counties. CARY was appointed Sergeant. On Jan. 8, 1862, he died of typhoid pneumonia at Camp Pickens, Virginia. His will was

probated in the July Term, 1863, Pike County Court of Ordinary.

On January 28, 1848, ISAAC (Jr.) and CARY STRICKLAND of Pike County, Georgia, bought Lot #242 District 5 in Fayette County (originally Henry Co.) from DAVID BELL of Chatham County.² On the 13th of November, 1849, ISAAC and CARY STRICKLAND of Pike County sold the west side of Lot #242 in Fayette County (which later became Clayton County) to POLLY ANTHONY of Fayette County, Georgia.³ (Note: ELIZABETH MUNDY, also known as POILLY, daughter of REUBEN MUNDY, married BOLIN ANTHONY in Fayette County on July 14, 1842.)

(2) ELKAHAN (also known as CAIN, CANEY or CAINEY), who stated in the 1850 Clayton Census he was 45 years old and was born in NC, is believed to be one of the elder sons of ISAAC (I). ELKANAH married ELIZABETH WHALEY on July 14, 1825, in Jasper County, and is listed on the 1830 Jasper County Census with two sons under 5 years of age, and one daughter between the ages of 5 and 10. CANEY drew land in the 1827 Georgia Land Lottery as a resident of Jasper County. He also drew land in the 1832 Georgia Land Lottery as a resident of Jasper County.

By 1840, CANEY was living in a section of Fayette County which was later to become Clayton County, Georgia. According to county records, he continued to live in the area.⁴ CANEY and his family lived on Land Lot #242 (Fayette) for awhile; and, it is told, made bricks on the property near his log cabin in the southeast corner of Lot #242. He later lived in a log cabin on a creek off present Brown's Road on Lot #210. Lot #210 was owned by his brother, KINCHEN, in 1845, but CANEY had acquired this land by 1852.

On December 22, 1870, CANEY was elected Receiver of Tax Returns for Clayton County. JAMES H. BROWN and J. L. H. WALDROP signed as securities for CANEY.⁵

(3) ISAAC STRICKLAND, JR., was born the 15th of April 1816 in Jasper County, Georgia. ISAAC married MARY HARTSFIELD on December 20, 1838, in Upson County, Georgia. His household is listed in the 1840 Upson County Census as: one male under 5; two males, 20 to 30; and one female, 20 to 30. The 1850 Census shows he was living in Pike County, Georgia. ISAAC married (2) MARTHA ANDREWS on January 12, 1864, in Pike County, after the death of his first wife in 1861. ISAAC died in Pike County on October 5, 1888, and is buried in Hebron Cemetery, Pike County, Georgia. (The Bible record of ISAAC STRICKLAND was printed in Strickland Scene, Vol. 1 pages 75-76.)

(4) KINCHEN, listed as 10 to 16 years of age in the 1820 Jasper County Census, was possibly living with CARY in Upson County (age 15 to 20) in 1830. KINCHEN married SUSAN E. SMITH on December 21, 1837, in Upson County. He was living in Fayette County (age 20 to 30) in 1840, with one female under 5, and one female aged 15 to 20.

On the 25th of July 1844, KINCHEN STRICKLAND bought Lot #210 and the south half of Lot #209 (Fayette County) from FURNA HUTCHENSON of Henry County, Georgia.⁶ The south half of Lot #209 was sold by ANDREW J. MUNDY, administrator of the estate of KINCHEN, to JOSEPH CAMP of Henry County on the 6th of July 1850.⁷

In the 1820-1854 Docket of the Court of Ordinary of Fayette County, Georgia, A. J. MUNDY is shown as administrator of the estate of KINCHEN STRICKLAND, deceased, dated March 1848. Securities are listed as JESSE WARD and REUBEN WALLIS. CANEY STRICKLAND was appointed guardian of KINCHEN's children: ELIZABETH, MARTHA, FRANCIS and MARTHA. By 1850, SUSAN and her children were living in Pike County, Georgia⁸; and, by 1852, CANEY had acquired Lot #210 of Fayette County.

(5) MILZY drew land in the 1832 Gold Land Lottery of Georgia as a resident of Jasper County. He is believed to have been living with ISAAC JR. in Upson County when the 1840 census was taken.

MILSIE E. STRICKLAND served as a witness to his brother's (ISAAC JR.) marriage to MARY HARTSFIELD on the 20th of December 1838 in Upson County, Georgia,

at the house of HENRY HARTSFIELD.⁹

It is believed MILZY moved to Alabama shortly after the 1840 census was taken. His brother, CARY, appeared before JAMES H. BLOCK (Justice of the Peace for Upson County) and stated MILZEY STRICKLAND died in Alabama on June 5, 1843.¹⁰

NORTH CAROLINA MILITIA WAR OF 1812

JESSE STRICKLAND (Stricklang/Stricklin)

Enlisted as a Private in Capt. THOMAS BOYKIN's Company, North Carolina Militia. He enlisted on 24 July 1813; and was "Discharged by Substitute Sept. 20, 1813. Capt. BOYKIN's Company is described as "Drafted Militia stationed at Deepwater Point."

STRICKLAND UNION VETERANS IN TENNESSEE 1890

STRICKLAND, JOSEPH - A resident of Roane County, Tennessee, in 1890. His post office was Rockwood. He enlisted as a Private in Company E, 1st Tennessee Infantry on 9 August 1861, and served until 17 September 1864.

STRICKLAND, WILLIAM - A resident of Washington County, Tennessee, whose post office address was Johnson City in 1890. He was a disabled veteran suffering from rheumatism. His military rank and unit is not known.

STRICKLIN, SAMUEL H. - A resident of Wayne County, Tennessee, in 1890. His post office address was Moon. He enlisted as a Private in Company B, 2nd Tennessee Mounted Infantry on 15 October 1863; and was discharged on 17 October 1864.

STRICKLIN, PETER O. - A resident of Henderson County, Tennessee, in 1890, whose post office address was Scotts Hill. He enlisted as a Private in Company H, 6th Tennessee Cavalry on 18 September 1862, and was discharged 26 July 1865. In 1890, he claimed to have suffered from chronic diabetes for 26 years.

- p. 55: Oct. 4th, 1746, at a Council held at Philadelphia, AMOS STRICKLAND's name had been returned to Council as Sheriff of Bucks County.
- p. 120: 3d October 1747, at a Council held at Philadelphia, AMOS STRICKLAND's name was presented as Sheriff of Bucks County.
- p. 345: 4th October 1748, at a Council held at Philadelphia, name of AMOS STRICKLAND, Esquire, returned as Sheriff of Bucks County.
- p. 345: At a Council held at Philadelphia, 5th October 1748, a letter from Mr. Lawrence GROWDEN, one of the Members of Council, was read, setting forth that he had received sundry Informations of male Practice in AMOS STRICKLAND, Sheriff of Bucks, at the late Election of Assembly Men for that County, & desiring the Board wou'd examine into the matter before they issued Sheriff's Commissions...

Ashford, Conn., and died 27 September 1798. She married first a NATHAN STRICKLAND (b. ca. 1766 - d. 3 January 1798). They had issue: 1) AARON TUFTS STRICKLAND, b. 24 September 1790; and 2) SALLY STRICKLAND, b. 19 December 1796. DEBORAH TUFTS STRICKLAND was married second to Peter S. MINARD.

In Strickland Scene, Vol. 2 No. 2 (1981), p. 24, under "Cotton States Exposition 1895," the ROSA STRICKLAND was my grandfather's sister who taught in the Birmingham, AL, school system for many years, receiving many honors for her work. We have received a notice that census microfilms are now available on a rental
basis. The National Archives has named the DDD Company as the contractor to carry
out this new rental program. The DDD Company will be contacting all public libra-
ries to provide details of program operation. The program will operate only through
public libraries and other institutions, such as genealogical associations. No in-
dividuals will be able to order microfilm directly from the contractor. Institutional

Individuals may order census microfilm from participating libraries and associa-
tions beginning in June, 1983 with actual distribution of the film scheduled to begin
in early July. The user may rent the film for a one-week (7 day) usage. The basic
seven-day rental for both 35mm and 16mm film (schedules and Soundex) is \$2.25. Over-
due charges of \$2.25 are assessed if the film is returned more than two days after the
designated return date which will appear on confirmation and packing slips. The
participating institution may charge an additional fee to cover handling and return
postage. A charge of \$12 will be made for damaged or lost film.
