MILLS' ATLAS, ATLAS OF THE STATE OF SOUTH CAROLINA 1825 by Robert Mills, Cartographer reprinted by Southern Historical Press, 1980, shows on the Horry District (County) map of 1820 a Strickland living near Lake Swamp on the road from Floyd's Ferry (at the boundary of Marion & Horry Counties) to Fork Road. This location appears to be 5 or 6 miles south of the North Carolina border.

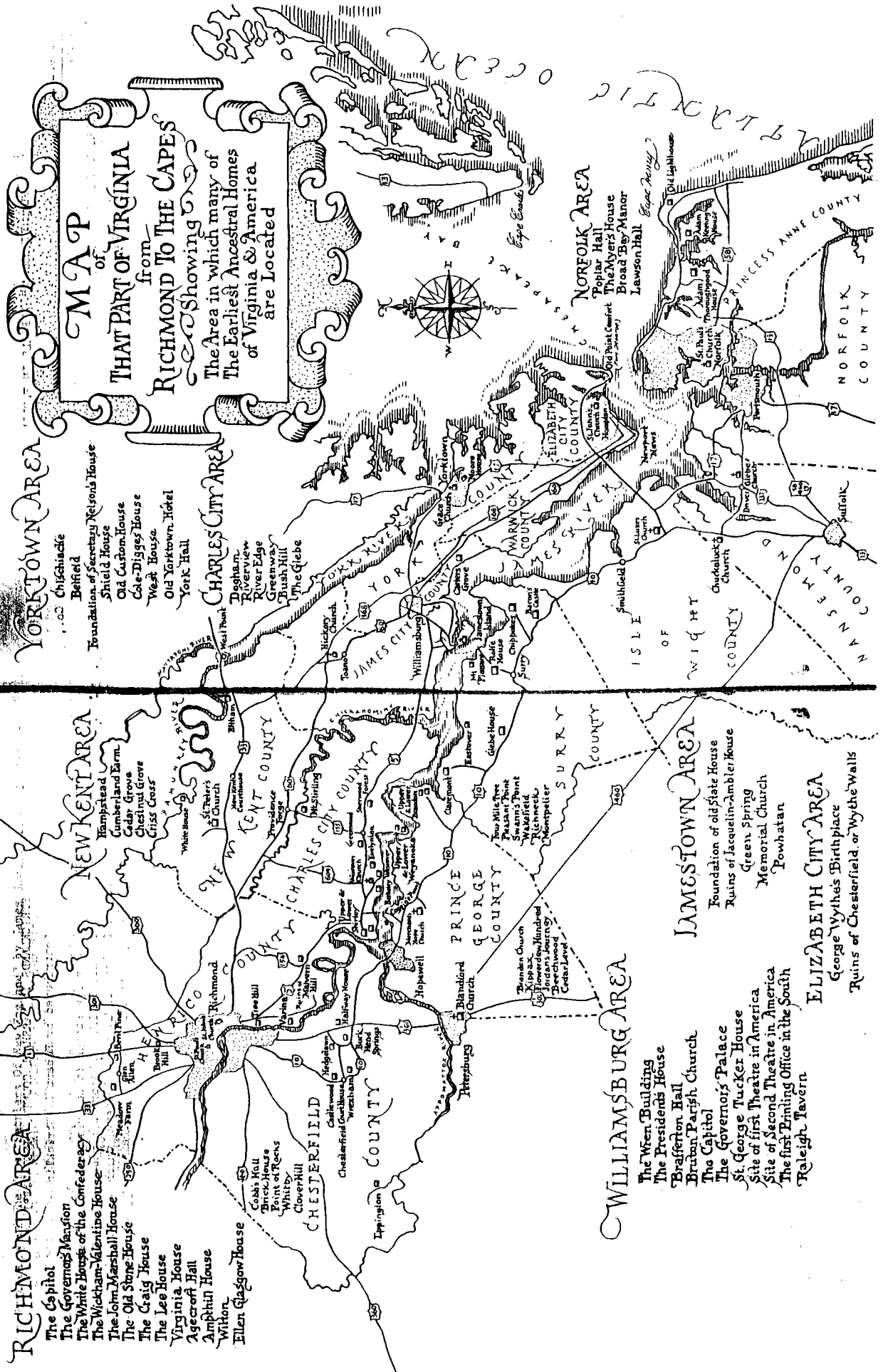

CONVERSATION WITH TITUS STRICKLAND FROM DRAPER MANUSCRIPT COLLECTION

Transcription by Robert C. Stricklin

The following is a transcription of a microfilm of Dr. Lyman C. Draper's manuscript of his conversation with Titus Strickland of Ste. Genevieve Co., Missouri, on October 14, 1851. The Draper Manuscript Collection, consisting of many thousands of pages of handwritten notes of historic interest, is owned by the State Historical Society of Wisconsin. This passage is from volume 5S, pages 39-44. Where a word is unclear even from context, it is indicated by a question mark in brackets following the word in question.

Tennessee Events &c.

From Titus Strickland, of St. Genevieve, Mo. Oct 14, 1851: Born Dec. 12, 1777, in the state of New York - when a child, was first taken to Penna., then Louisville a short time, & in 1786 to Ford's Station, at the mouth of Red River of Cumberland.

Says he was out in service scouting &c when only 12 years old: That about 1791, Capt. Wells of Red River assembled a party (thinks 600 men) went to the Bend of Tennessee & had a fight with Indians, & made a great defeat of them - killing 400 [ed. marginal note states "unreliable" re this fact] - almost as great a defeat as they met with subsequently at Nickojack: Mr. Strickland says he was along. (This is very greatly exaggerated - & is unworthy of credence.) Capt. Wells once ascending Cumberland River, & was wounded by Indians, the ball roughing [?] up his arm: He said he would kill Indians whenever he could: His first name not recollected.

Capt. Cowden had a blockhouse near the mouth of Sycamore of Cumberland, on the lower side: Was once riding from Clarksville to Prince's Station, at mouth of Sulphur Fork - & when 5 miles from the fortress was waylaid by Indians - he had two pistols & a double barrelled

rifle - shot one Indian with one barrel of his rifle, & another with the other; then drew his pistols & shot two others - & made off back to Clarksville: Mr. Strickland was there at the time: Cowden raised a party - went to the spot - found three dead Indians, & signs of a fourth having been wounded. This happened in the summer of about 1791. - Capt. Cowden was a U.S. officer, sent to superintend the erection of blockhouses, & keep out scouts &c. He was afterwards killed on the wilderness road going to Ky.

Col. Ford was from Virginia - married a daughter of Mr. Prince of Prince's Station. Elihu Strickland, (a brother of my informant, sometime deceased) was out on the Coldwater Campaign in 1787 - & fired the first gun, killing a Frenchman, shooting him through the forehead - & got his fine rifle & accoutrements, & his cap with

a bullet hole shot the band in front.

Nickojack Campaign - 1794. Rendezvoused near Nashville - Mr. Strickland being in Capt. Thos. Johnson's company: When in anger [?], privilege was given to all who did not wish to go, to return home - a good many went home - perhaps a hundred. 600 men went. At the Tennessee, almost 4 miles below Nickojack, the men crossed, except a few who could not swim, or did not choose to go & take part. La Mar could not swim, & was anxious to cross & fight - some aided him to build a cane raft, & went over: He was brave. The troops were arranged into 3 divisions - Capt. Ford, Middle Division - Strickland was one of this division. The Indians made no defence, but ran off, some towards Running Water, when Col. Whitley attacked them. At Nickojack was a store, & evidences (marks) were found in it, that it belonged to Gov. Wm. Blount - the troops were so incensed, that they burned the whole - & Blount was thus destroyed as a public man - arrested &c.

No recollection abt. Jackson or Weakley.

Nickojack Campaign - Col. Montgomery - Capt. Pike

Probably Col. Montgomery commanded the middle division - of which was Ford's company. When the Indians were routed, some of them were shot in attempting to cross the river, not only by those attacking Nickojack, but by those who did not cross, but posted themselves opposite the town.

On the return, LaMar was sentinel in the rear, got crazed, & ran through the camp calling out "Indians! - Indians!" & then climbed up a tree so high that the top broke with him & he fell - was then insensible & died on the return.

All the Indians were killed except nine - one of whom Mr. Strickland said who so informed him, at Fort Manac, in March, 1795 -

Fort Manac - Mh. 1795, was commanded by Capt. Pike, father of Genl. Zebulon Pike, killed at Little York - then a bright lad of some 12 years with his father. Subsequently Capt. Bissell commanded that post.

Col. John Montgomery. - Was in Nickojack campaign, & soon after killed by the Indians (Nov 1794.) He was said by all who knew him, to

have devoted all to aid others, & for the public good - & died poor. He was 6 feet - ruddy - martial - good looking - sociable, & well informed.

Capt. Robt. George - the Kaskaskias - DuCoigne.

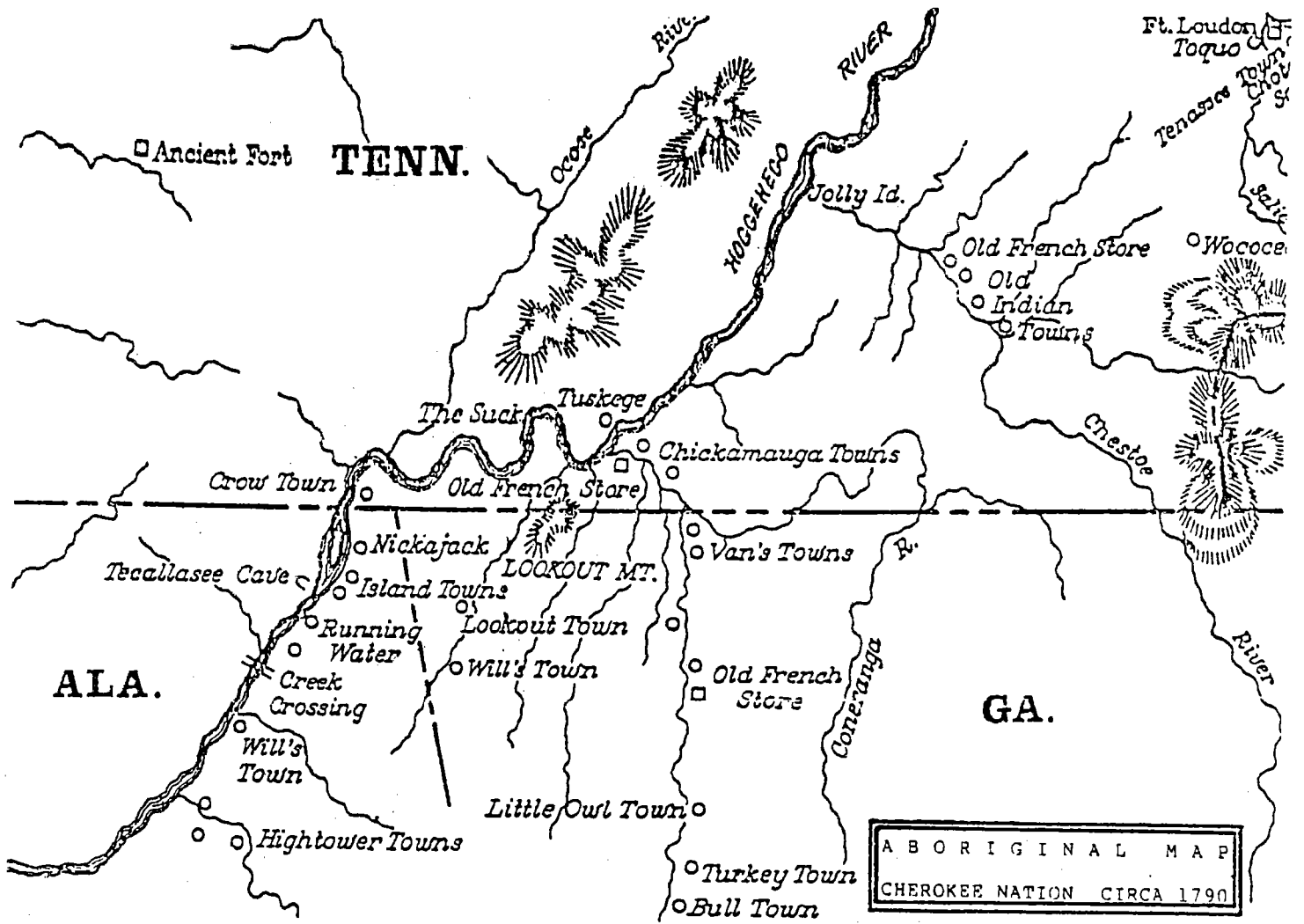
Mr. Strickland came to Kaskaskia, Jan 31st. 1795. His wife, whom he married in now Indiana, above Louisville a few miles, was neice [sic] to Capt. Robert George - who lived 8 miles above Louisville, on the river bank, on his portion of Clark's Grant: He had no family - don't exactly know when he died, nor certainly where: But probably died there, aged: He was living there when Mr. S. was married in 1800, & when he returned there in 1811, Capt. George was dead, don't recollect that his death was spoken of as a recent occurrence [sic].

The Kaskaskias (say Mr. Strickland & Mr. St. Jamme - & Mr. Danais) had a severe battle with the Sacs & Foxes, at an Early period, about 20 or 25 miles from Kaskaskia, on the rout [sic] to Manac (to Shawneetown, says Mr. Danais) on Big Muddy, or rather perhaps Bookoo Creek (bookoo - buffalo or bear's hides made into a sort of bag or receptacle for oil, & two of them swung over a horse - Mr. St. Jamme). Mr. Strickland says the Kaskaskias were greatly overpowered & beaten - Mr. Danais, says they were victorious. Many bones were seen on the spot by Mr. Strickland - who adds, that some remains are yet to be seen there. Mr. S. P. DuCoigne was there, while Mr. St. J. & Mr. D. say it was before his day.

Clark's ruse de guerre at Vincennes vs Ft. Chartres.

Mr. Strickland says that he had it from Capt. George, & an old Frenchman, that Clark took Fort Chartres by a ruse de guerre. That he & his men appeared at a point of a knob about 6 miles East of the fort - at the range of hills skirting the American bottom - & marched & re-marched his men over the point of this knob & down into the bottom &c. Then sent in a flag (in sight over the plain) & the British commandant surrendered: When Clark took possession, the British officer asked Clark where all his troops were? Clark said all were there. The British officer, chagrined at his own act of surrender to so small a handful of men, wanted to kill himself.

Mr. St. James says this does not apply to Fort Chartres, which, as his father told him, was long before abandoned on account of the river encroachments - but that it was true of Vincennes: So also says Mr. Davis. - Mr. S. resides at St. Genevieve, & says his daughter will write for him if I require information.
