SAMPSON STRICKLAND OF REVOLUTIONARY WAKE COUNTY, N. C.:
A TALE OF TORY DETERMINATION

A great many tragedies, and perhaps as many tales of courage and sacrifice, could be written if those of us who dig into our family's "roots" could learn the complete stories behind the written records of events in our ancestors' lives! We can only wonder about what motivated SAMPSON STRICKLAND, Sr., middle-aged husband and father, solid citizen and prosperous farmer, to stand up in the Wake County Court of Pleas and Quarter Sessions in December, 1777, and steadfastly refuse to swear the Oath of Allegiance to the State of North Carolina. By his refusal, SAMPSON placed himself with the despised Loyalists and was therefore ordered to leave the state. In some parts of North Carolina, "Tories" were numerous and could support each other against revolutionary pressure; such was not the case in Wake County.

The Oath, devised as part of the state's Treason Act of 1777, was unequivocal: "I will bear faithful and true Allegiance to the State of North Carolina, and will to the utmost of my power support and maintain, and defend the independent Government thereof, against George the Third, King of Great Britain, and his Successors. . . ."

Unlike other British sympathizers, SAMPSON STRICKLAND was not a recent immigrant to these shores; as the youngest son of MATTHEW STRICKLAND, Jr. and his wife ANNE BRACEWELL, he descended from several generations of Virginia colonists. His nearest tie to the pro-British Anglican clergy appears to have been no nearer than a maternal great-grandfather, Rev. ROBERT BRACEWELL, parson of the Lower Parish, Isle of Wight County, Virginia, whose death preceded SAMPSON's birth by more than fifty years. Neither was he a merchant who profited from trade with the British. For whatever cause, even in the face of overwhelming opposition, this STRICKLAND found himself unable to renounce his loyalty to the English crown.

Carolina Citizen

Born in 1723 in Isle of Wight County, Virginia, SAMPSON STRICKLAND moved south as a young man, receiving a Granville grant patent May 24, 1756 for 275 acres of land in what was then Johnston County, North Carolina. (The Powell Creek area where he settled was divided in 1770 to create Wake County.) Court records include more than a dozen references to SAMPSON thereafter: he recorded deeds, witnessed others' land transactions, registered his cattle brand. In addition to his agricultural pursuits, he accepted a number of civic responsibilities, serving as juror, caretaker of an orphan, road committee member, and road overseer.

By the time colonial fervor for independence rose high, SAMPSON STRICKLAND must have been quite thoroughly settled among his Wake County neighbors, doubtless cherishing hope that eventual reconciliation with the mother country might be achieved. But as the strife between England and her colonies increased, it became impossible for North Carolinians to remain tacit royalists. A rather mild loyalty oath in which persons suspected of sympathizing with the crown swore not to bear arms against or otherwise oppose the revolutionary government "during the present unhappy contest between Great Britain and America" was ultimately replaced by a much more stringent avowal; all who lived within the colony that had proclaimed itself a state were to be compelled to declare their allegiance to it.

As 1777 drew to a close, SAMPSON STRICKLAND may have already refused the oath in a muster of men in his militia district, or he may have been singled out and summoned to court as a suspected British sympathizer. At any rate, two other men appeared in court the same day as SAMPSON; they each swore the oath and were given certificates as evidence that they had "complied with the Law."

SAMPSON STRICKLAND, however, defied the court, the law, and popular opinion: ". . .being Cited to appear at this Court to take the Oath of Allegiance to this State came into Court, and on said Oath being offered to him he refused taking the same, whereupon the Court Pronounced his Banishment agreeable to Law."

Death in Exile?

It is probable that SAMPSON was banished as ordered, but where he went remains a mystery. Did he go to the West Indies or to Nova Scotia, as did other Loyalists? Did any of his family go with him? Was any of his property confiscated?

The records do not offer much information. In fact, SAMPSON STRICKLAND must have died in exile, because his name does not appear in the court minutes from the time he was sentenced until after his death, when his widow CHRISTIANA reported his estate inventory in July, 1781. In March of the next year, she received from the court permission to act as her husband's administratrix, posting bond for 700 pounds. In June the court accepted an account of the estate sale from the deputy sheriff (buyers included CHRISTIANA, OBEDIAH, ABEL and HARDY STRICKLAND, along with SAMPSON STRICKLAND, Jr. In March, 1783, CHRISTIANA sought guardianship of her younger children--OBEDIAH, ABEL, MARY ANNE, LOT, BRASWELL, and MATTHEW, for which she was required to enter bond of 1,200 pounds. In May, 1784, OBEDIAH achieved his majority and purchased 250 acres of what had doubtless been his father's land from the deceased Tory's eldest son and namesake, SAMPSON, Jr. CHRISTIANA, their mother, co-signed the deed with her mark. One of the witnesses, JOSEPH STRICKLAND, may have been another older son of SAMPSON the elder and CHRISTIANA. LOT STRICKLAND's December, 1784, will names his mother and brothers, BRASWELL and MATTHEW, with OBEDIAH as an executor and ABEL and JOSEPH as witnesses.

It is unlikely that many of SAMPSON STRICKLAND's legion descendants would agree that his refusal to support the new state was justified; history has certainly shown that the American Revolution was not only inevitable but beneficial. However, those of us who descend from this stubborn Wake County Tory should take some pride in his bravery, and hope that we might have inherited a modicum of that quality in his character which resulted in this sacrifice of home and a comfortable future for principles and loyalty.

The Second Sampson

The Loyalist tendencies of SAMPSON STRICKLAND, Sr. did not descend to his namesake. The younger SAMPSON (1752-1839) served two tours of active duty with the Wake County militia, according to documents in a pension claim filed by his children. Whether he went eagerly or reluctantly, this SAMPSON went off to battle against the British, recalling to his family years later how at the Battle of Stono Ferry, South Carolina (1779) the bombshells were "playing about their heads like hail showers." A summary of the pension material appears in STRICKLAND SCENE, Vol. 7, No. 1, page 5.

DATA FROM THE MILITARY PENSION FILE OF
WILLIAM STRICKLAND (1842-1919)
JOHNSON CITY, WASHINGTON COUNTY, TENNESSEE

WILLIAM STRICKLAND was born on 15 January 1842 in northwestern North Carolina. He variably gave his birthplace as Salisbury (Rowan County) or Wilkesboro (Wilkes County) or Watauga (Watauga County, after county's formation January 1849).

He was enrolled 18 September 1861 at Boone, Watauga County, North Carolina, as a private of Company E, 37th Regiment, North Carolina Infantry, Confederate States Army Volunteers, by WILLIAM Y. FARTHING, for an enlistment of one year. At that time, at age 19, he gave his birthplace as Watauga, North Carolina, his occupation as farmer, his height as six feet. His oath of allegiance to North Carolina was reportedly signed WILLIAM STRICKLANE. He was reported missing in action 3 July 1863 at the Battle of Gettysburg, and captured while slightly wounded there.

He was enrolled on 26 February 1864 at Point Lookout, Maryland, as a private of Company F, 1st Regiment of U.S. Volunteers ("Rebs"), for an enlistment of 3 years. He was reported sick in the hospital at Fort Ridgely from 29 October 1864 to 30 April 1865, and briefly at other times. He was reportedly disabled at Fort Ridgely about December 1864 by injury to his testicles, from a saddle mule falling with him while hauling wood. At Fort Fletcher, Kansas, he contracted rheumatism and kidney disease about February 1866. (In 1912 he referred back to "disease of heart, and disease of lungs, of service origin".) He was mustered out with the company at Fort Leavenworth, Kansas on 10 May 1866.

WILLIAM married LUCRETIA NEAD on 7 October 1866 near Jonesboro, Washington County, Tennessee, with JOHN WALTERS, J.P., officiating. This was the first marriage for each of them. They had five children who lived, DANIEL N. STRICKLAND, born 24 July 1867, DORA STRICKLAND, born 19 April 1869, CORA STRICKLAND, born 7 April 1871 or 1872, WILLIAM F. STRICKLAND, born 29 August 1874 or 30 August 1873, LUTHER N. STRICKLAND, born 10 July 1876, plus two infants who were stillborn. LUCRETIA died on 3 April 1899 at their home on Henry Street in Johnson City, Washington County, Tennessee.

On 1 January 1904 WILLIAM married MARY L. HOPSON, with A.H. BULLOCK, J.P., officiating. MARY was previously married to L.P. HOPSON, from whom she was divorced in 1892 at Elizabethton, Tennessee. It became evident they could not live together, and they separated after seven months. On 8 April 1905 MARY made a declaration attempting to claim half his pension, which was countered by WILLIAM on 29 August 1905 by a declaration in which he stated he had obtained a divorce from her on 25 August 1905. He then lived on Henry Street in Johnson City, Tennessee, in the house where he had resided for about 15 years, "save for the short interim I undertook to live with the said MARY STRICKLAND as her husband." He wrote that since the death of his first wife, LUCRETIA, his youngest daughter (presumably CORA) had been living in the house keeping house for him. One questionnaire, which contained some inconsistencies in dates, stated his second wife, "MARY L. HOBB", died in 1905. A 1919 affidavit of WILLIAM's son, WILLIAM F. STRICKLAND, noted only that MARY STRICKLAND, the second wife, "had since died".

On 11 March 1911 WILLIAM married Mrs. ELIZABETH DUNBAR, with Reverend G. ERNEST MOODY officiating, as recorded in Marriage Record Book 5, page 348, at Washington County, Tennessee. Her maiden name had been ELIZABETH HARVEY. She was married in her teens to FRED MONGOL, from whom she was divorced in Washington County, Tennessee, and then to GEORGE DUNBAR, who died in Johnson City, Tennessee about 20 December 1909. Neither of her prior two husbands were ever in the military service of the United States.

WILLIAM died on 13 June 1919 at the Mountain Branch, National Home for Disabled Volunteer Soldiers, address National Soldiers Home, Johnson City, Washington County, Tennessee, of chronic bronchitis. The address of his wife LIZZIE was given at the time as National Soldiers Home, Tennessee (North Gate).

In a 30 July 1919 affidavit by WILLIAM's son LUTHER N. STRICKLAND in support of

ELIZABETH's pension claim, it was stated that WILLIAM left no children by either his middle or last marriage. LUTHER's address at the time was Route 1, Johnson City, Tennessee.

WILLIAM's widow, ELIZABETH STRICKLAND, died 9 November 1930. Her address at the time was 916 East Watauga Avenue, Johnson City, Tennessee.

SOME CENSUS DATA RELATED TO WILLIAM & LUCRETIA STRICKLAND
OF JOHNSON CITY, WASHINGTON COUNTY, TENNESSEE

No census records were located for STRICKLAND or variant spellings for Rowan or Wilkes Counties, nor Ashe, Caldwell and Yancey (the other three parent counties from which Watauga County was formed January 1849) for the years 1840 and 1850. The following entry was the sole potentially related listing shown in 1850 for Watauga County, nestled between the Blue Ridge & Stone Mountains, along the North Carolina-Tennessee border:

DATA FROM THE CIVIL WAR PENSION FILE OF
SETH STRICKLAND (1828-1899)
OF RAVENNA, OHIO & ELLSWORTH, WISCONSIN

The earliest events recorded in the pension file of SETH STRICKLAND were the birth of his son, HALE STRICKLAND, on 8 May 1856, followed by the death of his wife CAROLINE M. STRICKLAND five days later, 13 May 1856. His wife ADA E. died 9 January 1863. No other wives or children were mentioned. HALE was living as of a 14 December 1897 declaration by SETH.

SETH STRICKLAND was drafted 21 March 1865 into Company H, 39th Regiment, Ohio Infantry "Volunteers". He was honorably discharged at Louisville, Kentucky 9 July 1865.

On 2 February 1891, at age 63 and a resident of Ellsworth, Pierce County, Wisconsin, SETH applied for a pension based on total disability from "hernia of left side, hemorrhoids and chronic bronchitis." This declaration was witnessed by ALMIRA L. STRICKLAND and I.M. WOODWORTH.

In October 1897 he re-applied at Ravenna, Portage County, Ohio, having moved from Wisconsin and his attorney there having died. He stated that since his previous application "my eye-sight has failed, my hearing also, and I have eczema, and swelling of the lower extremities." EUNICE FAIRCHILD witnessed this declaration.

On 5 March 1898 F.C. APPELEGATE, M.D., age 77, a resident of Windham, Portage County, Ohio, stated that he had known SETH for about 48 years, "much of the time quite intimately as his family physician." On 7 March 1898 ALBERT McCLINTOCK, age 60, of Ravenna, stated that he had been acquainted with SETH for the last 27 years, and knew him to be "a sober and peaceable man", with "no vicious habits of any kind, what-ever" (a fairly routine denial on pension affidavits, as "vicious habits" contributing to disability would be grounds for disqualification).

On 16 May 1898 J.S. SMITH, age 62, of Ravenna, a Clerk of Courts, stated regarding SETH that he had been acquainted with him the last 35 years, since 1863, and that he "hardly ever speaks, unless he has some-thing to say. That is, I mean to say, that he is a very still, quiet sort of man."

On 19 May 1898 SAMUEL A. PARDEE, age 68, of Windham, declared that he had been acquainted with SETH since their boyhood, and was in SETH's company nearly all his life. SAMUEL described SETH as being "a man of extra good character" and "a man of few words, therefore never tells much to any one" (particularly mentioned with respect to SETH's failure to talk about his disabilities when they first occurred). SETH had bronchitis, "in particular since about 1884, and he has been getting worse since."

SETH STRICKLAND died 15 January 1899, according to information received by the Pension Commissioner from the Ravenna Postmaster.

WAR OF 1812 BOUNTY LAND WARRANT APPLICATION FILE DATA REGARDING
JOHN STRICKLIN (ca.1790-1867) OF HOLT COUNTY, MISSOURI

The bounty land warrant application file of JOHN STRICKLIN supplements the data in the file of the pension claim of his widow CATHARINE HUNSUCKER STRICKLIN. In some cases the data in this file corroborates that of the other. Where there is some variation in the data, one would expect that this earlier data provided directly by JOHN STRICKLIN would have greater accuracy.

On 9 November 1850 in Calloway County, Missouri, JOHN STRICKLIN, age given as 60 years, then a resident of Montgomery County, Missouri, made a declaration before Justice of the Peace JOSEPH T. BRYAN for purpose of obtaining bounty land under the Act of 28 September 1850. JOHN declared that he served as a private in the company of Tennessee Militia commanded by Captain ALEXANDER HILL, who was promoted to major, at which time Captain CUNNINGHAM took command. The regiment of which his company was a part was under the command of Colonel HENDERSON up to the time of his death, and thereafter under Colonel SIMPSON. He volunteered in Warren County, Tennessee on or about 1 October 1814 for the term of six months, and continued in service until peace was restored, an elapsed period of five months. He was honorably discharged at COLBERT'S Ferry on the Tennessee River on or about 1 April 1815. He moved to Missouri shortly after he returned home. Calloway County Court Clerk J.J.B. GRANT certified the authority of Justice of the Peace BRYAN on the document on 17 December 1850.

Notations in the file from the 3rd Auditor's Office showed JOHN to have served from 13 November 1814 to 13 May 1815, a period of six months. Warrant #15,220 for 80 acres was issued to JOHN STRICKLIN on 12 September 1852, and sent in care of CHARLES H. HARDIN, Fulton, Missouri, who had presented bounty land claim #42,962 for JOHN. Volume 59, page 209 was noted on the file. This warrant for 80 acres was cancelled and replaced by one for 160 acres, through the subsequent claim described below.

On 15 January 1856, JOHN STRICKLIN, then a resident of Holt County, Missouri, age given as 68 years, made a sworn declaration that he served as a private in the company commanded by Captain ALEXANDER HILL in the War of 1812; that he volunteered at Warren County, Tennessee in 1813 or 1814 for six months service, and continued in actual service for the term of "fourteen days and upwards" (the minimum requirement for award of bounty land?) and was honorably discharged at the Tennessee River in Tennessee in 1814; that he previously made application No. 233,533 for bounty land under the Act of 28 September 1850 and received warrant no. 15220 for 80 acres, which he was therewith returning, asking for a warrant of 160 acres. That declaration was signed and acknowledged before JAMES FOSTER and CHARLES PATTON, both of Holt County, and R.G. EMERSON, Justice of the Peace. A.B. MULLINS was clerk of the Holt County Court. His attorneys for this claim were FOSTER & COLLINS, Attorneys at Law, at Oregon, Holt County, Missouri.

On 25 July 1856 at Holt County, Missouri, JOHN declared before Justice of the Peace R.G. EMERSON that he could neither read nor write, and that the reason his signatures had varied on certain prior documents was that different persons had signed them at his request. His signature normally was an "X" witnessed by others.

On 26 August 1856 Warrant No. 38,480 for 160 acres was issued to JOHN STRICKLIN for his service as a private in Captain ALEXANDER HILL'S Company of the Tennessee Militia in the War of 1812, under the Act of 3 March 1855.

WAR OF 1812 BOUNTY LAND & PENSION CLAIM FILE DATA CONCERNING
JESSE STRICKLAND (ca.1789 - 1 November 1865)
OF SAMPSON COUNTY, NORTH CAROLINA AND DALE COUNTY, ALABAMA

JESSE STRICKLAND volunteered (widow's application states "drafted") in Sampson County, North Carolina, and served 62 days from 11 July 1813 until 10 September 1813, as a private in Captain Thomas BOYKIN's "Company of Foot", in the regiment of North Carolina militia commanded by Colonel John A. CAMERON or David EVANS (he was unsure which). He was honorably discharged at Ft. Johnson [or Waterington (sp?)], North Carolina. At the time of his enlistment he was a farmer, 5'10" in height, with blue eyes and dark hair.

JESSE had a wife who died in Sampson County, North Carolina, several years before his marriage to MARTHA FARMER in Dale County, Alabama, on 15 March 1846 before J.K. Hutto (sp?), Magistrate. JESSE and MARTHA resided in the neighborhood of Skipperville, in Dale County, Alabama.

On 8 December 1852 at age 63 years and identified as a resident of Barbour County, Alabama (adjoining Dale), JESSE applied for bounty land under the Act of 28 September 1850. He obtained land warrant No. 84972 for 40 acres, that he later "legally disposed of".

On 7 April 1865 JESSE made application for additional bounty land under the Act of 3 March 1855. This application was witnessed by JOHN HAGLER and JOHN CAIN, residents of Dale County.

When JESSE made application under the 1850 act he signed his own name, but according to later testimony on 1 February 1856, when he had made application under the 1855 act, he "was in bad health, laboring under a disease called asthma and could not write his name, and signed his declaration by making his mark."

JESSE died 1 November 1865 near Skipperville, Dale County, Alabama. His widow MARTHA signed a claim for a widow's pension on 23 Feb 1880, witnessed by CHARLES PELLUM, age 59, and ISAAC N. WOOD, age 49, both of whom resided near JESSE and MARTHA near Skipperville.

MARTHA died 16 June 1882. She had been cared for by JOHN CAIN (see above) for several years before her death. She was described as being blind and helpless four years before her death. "She was so old that she lost hir eye sight and had to be ceard for as a little child."

Her claim was rejected on the ground of death of claimant prior to the completion of her claim. The above data is drawn from National Archives combined file W.O. 39,335 & B.L. Wt. 55,585-120-55.

WILLIAM STRICKLAND (1788-1854)

"Architect, engraver, painter, and draftsman. Born in November 1788 at Navesink, New Jersey, STRICKLAND was apprenticed in 1803 to the architect BENJAMIN H. LATROBE, with whom he remained about two years. After a season of scene painting at the Park Theater in New York City, STRICKLAND began his independent career as an architect in Philadelphia in 1809, though for a number of years he supplemented his income by surveying, engraving, and painting. His first important architectural commission came in 1818, the 2nd Bank of the United States, and many others followed during the next two decades. Although he employed various styles, STRICKLAND is generally associated with the Greek Revival in America. From 1819 to 1846 he was also a Director of the Pennsylvania Academy. He visited Europe with his family in 1838, making many water-color sketches which have been preserved. In 1845 STRICKLAND moved to Nashville, Tennessee, and was engaged as architect of the Tennessee State Capitol there until his death, April 6, 1854." 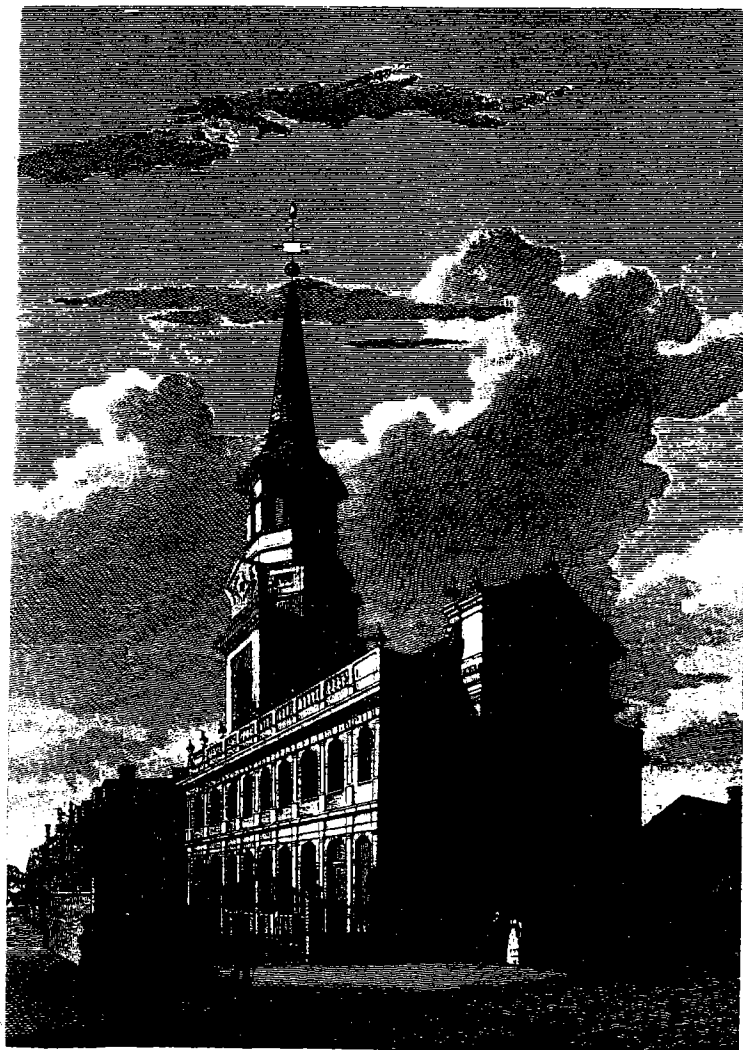
Above is a copy from an engraving of a drawing by WILLIAM STRICKLAND of the United States Mint in Philadelphia, which building he designed.

The 1850 U.S. Census of the City of Nashville, Davidson County, Tennessee, shows WILLIAM STRICKLAND as household #706 in the Sewanee House Hotel, at age 62, born in Pennsylvania, along with RACHEL STRICKLAND age 55, born in New Jersey, ELIZABETH STRICKLAND age 23, born in Pennsylvania, and his son F.W. STRICKLAND, age 20, born in Pennsylvania, who carried on the construction of the Tennessee state capitol the five years following WILLIAM's death. When WILLIAM died, his funeral was conducted in the hall of the Tennessee House of Representatives, and he was entombed in a recess of the wall of the north portico!

GEORGE STRICKLAND (1797-1851)

"Landscape and architectural draftsman, born in Philadelphia in 1797, a younger brother of WILLIAM STRICKLAND, under whom he studied drawing, painting, and engraving. He exhibited a scene from Scott's Marmion at the Pennsylvania Academy at the age of 17; in 1826 he exhibited sepia drawings of Philadelphia scenes, then being engraved for CHILDS' Picturesque Views. Unsuccessful in his attempt to become an architect, he taught drawing for a while at the Franklin Institute, but sometime in the thirties moved to Washington and became a Patent Office clerk. He was buried in Washington in April 1851." [New York Historical Society's Dictionary of Artists in America (year?), p.610.]

JOHN STRICKLAND OF PENNSYLVANIA, 1757-1849

John Strickland was born in Bucks County, Pennsylvania in 1757. In 1806, he immigrated to Jefferson County and located in Philadelphia, then a part of Le Ray. He was a member of the Society of Friends, and was possessed of a genial and kindly disposition. He brought with him a sum exceeding \$25,000, with which he purchased 5,000 acres of land in town. During the War of 1812, he bought supplies for the American Army, and at the termination of the war had a large quantity of supplies on hand, for which he received less than half their original cost. He was obliged to dispose of a large portion of his land to pay his indebtedness, after the accomplishment of which he had left of his vast estate only 220 acres. He died September 15, 1849, aged 92 years. At the age of 25 years he married Margaret Stout, of German descent, with whom he resided 60 years. She died in 1853. Of their children, Elizabeth married Thomas Townsend, and died in 1864; John Jr. married Rachel Townsend and died 1859; Sara married Ezra Comley and died in Pennsylvania in 1855; Deborah died in infancy; Ann married Edmund Tucker and died in 1863; Mahlon married Mary, daughter of James Rogers, and died in 1871; Margaret married Samuel Case and died in Chicago in 1888, aged 91 years; Rachel married Samuel Rogers and died in this town in 1863; Miles married Robert Gray and died in Wisconsin in 1875; Seth, who was born in 1808, married Jane, daughter of Thomas Bones, January 25, 1835. Of their children, Ellen (Mrs. Isaac Mosher) and William reside in this town, and John E. in Carthage. William Strickland was born October 15, 1839 and was reared upon the homestead farm, which he inherited. He married Betsey J., daughter of Truman and Fanny (Alles) Oatman, of Philadelphia, December 29, 1862, by whom he had two children, Seth T., born March 12, 1866, who died May 7, 1871, and Anna Jane, born April 2, 1874. Mr. Strickland is a farmer and resides in the village.

The associated correspondence was dated late 1958 and early 1959.
