TWO STRICKLAND DEEDS IN ELBERT COUNTY, GEORGIA

The following deeds were located on microfilm at the Georgia Department of Archives & History. The first deed was originally granted to Solomon Strickland by the Governor of Georgia on 24 January 1791 at which time it was in the county of Wilkes. By 1795 it was a part of Elbert County.

ELBERT COUNTY, GEORGIA DEED BOOK C, p. 140:

This indenture made this twenty seventh day of February in the year of Lord One Thousand Seven Hundred and Ninety Five and in the twentyeth year of the American Independence, Between Solomon Strickland of the County of Elbert and State of Georgia of the one part, James Rogers of the County and State aforesaid of the other part, Witnesseth that the said Solomon Stricklen for an in consideration of the Sum of twenty pounds Sterling to him in hand paid the Rect. whereof is hereby acknowledged hath granted sold _____ and confirmed and by these presents doth Grant Bargain Sell Alien and confirm unto the Said James Rogers his heirs and assigns for ever all that track or parcell of Land Situated lying and Being in the County and State aforesaid on the Waters of Blue Stone Creek. Beginning at a Poast Oak on Cades Corner thence runing along Cades line to Cargels Corner at pine thence along Cargels line to Mac intyers Corner at a dogwood thence along Macintyres line to Hemphills Corner at _____ thence a direct corse to the Beginning. Containing Forty acres more or less together with all and the writs advantages and profits whatsoever to the Said land and premisses belonging _____ and also Reversion _____ Reversions, Rents, and S _____, of the said premisses and every part thereof and all the State writes, tittles _____ claims and demands whatsoever _____ the Said Solomon Stricklen _____ to the Said track of Land and premisses and every part thereof with all the appertain _____ to the Said James Rogers his heirs and assigns to their only proper use and behoof for ever. And the Said Solomon Strickland for himself his heirs and assigns doth warrant and defend the Said Land and premisses from any person that shall _____ to lay any claim thereunto to him the Said James Rogers his heirs and assigns forever, in Witness whereof I have hereunto set my hand and Seal the day and year above writen.

To a black oak & thence runing S ___ W 45 Chains thence to Acocks line Post oak & thence along the Said line S. 65 W. 20 Ch. to a Red oak & thence along the Said Acocks line N. 25 W 53 Chs. P. oak & thence Runing S. 80 E 25 Chs. to ___ P. Oak & Thence to the begining S. 10 W. 64 Chs. Which Said tract of land with all and singular the appertanences thereof to have and to hold unto the Said Strickland and his heirs the Said Thompson Doth Warrant and defend the Said tract of Land from him and his heirs and no further to Said Strickland and his heirs in & to the Said land and premises, In Witness whereof the Said Thompson hath hereunto Set his hand and Seal the Day and year above mentioned, Signed Sealed and delivered in Presents of

ISAAC THOMAS STRICKLAND

Newspaper Clippings Contributed by Cherryl Weil

Our thanks to Cherryl Weil for the many newspaper articles she has contributed to us. This collection of articles were written by and about Isaac Thomas Strickland. Many of his articles pertain to the early days of settlement in the Oklahoma Territory. Isaac Thomas Strickland was born 14 March 1859 in Missouri, the son of Narcissus Adaline LESSLEY of Stoddard Co., MO, and John T. STRICKLAND, born 5 July 1828, Gwinnett Co., GA. The following are 3 articles about I. T. Strickland.

OPENING OF THE STRIP 36 YEARS AGO by I. T. Strickland

Well do I remember the day of the opening of the Cherokee Strip to settlement 36 years ago. There were five of us who had trained our horses together for the run, Charley and Babe Morris, Joe Strickland, Bob Julian and the writer. All of these are dead except Julian and the writer.

We had conditioned our horses by loping them around the Landis section ten miles north of Kiowa, trying them out at least once a day for nearly a week before the race and feeding them oats and hay.

When September 16 arrived we mounted and leisurly rode down to Kiowa and as the noon hour drew near we moved down to the strip line about a quarter of a mile west of the city, with hundreds of other home-seekers, who kept arriving until the noon-hour which was to be the time for the gun to fire to let us ride into the great unknown country.

We were mounted on the pick of our horses and with the American flag we were all set to go. When that soldier raised his arm all the talking ceased and the crowd was quiet and every eye was on the soldier. Everyone leaned forward in his saddle and hardly had the shot left the gun when away we went like the wind, headed south with hundreds ahead and hundreds behind.

The ones in the lead had an objective point to work on as the majority headed for the Salt Fork valley, having been over the country before and knew about where they wanted to go. Every conceivable vehicle was in that race. The ladies - bless their souls - were there in numbers, and one lady driving a spring wagon had grief at the crossing of Little Mule creek, south of where we had started - as the best we could see she or they lost one wheel. This was one time that chivalry of the gentlemen failed, as they had business ahead which was very urgent indeed.

We staked our claim from horses' backs by throwing our stakes which were armed with the American flag and jumping to the ground immediately, pulled our watch and discovered that we had negotiated the distance from the starting point to our claim which is east of Alva, seven and one-half miles, in one hour and ten minutes after the gun was fired. We still reside on that old claim and have seen every tree and house and everything come to the front as there was nothing except buffalo grass there at that time.

DEATH NEAR FOR PIONEER

Condition of I. T. Strickland, pioneer, who has been ill at his home for the last few weeks, was unimproved today and little hope is held out for his recovery. The pioneer who made the run and homesteaded on his farm seven miles east of Alva has been in poor health for the past year. Trips to Anthony, Halstead and Wichita for treatment have failed to give him relief.

Recently his condition became grave. He is now bedfast and unable to receive

visitors.

Mr. Strickland came to Oklahoma during the run and homesteaded on his farm seven miles east of Alva on highway 64. He held at one time extensive real estate in the city proper and educated his children in schools here. Two years ago he moved with his wife to the residence on Fourth street which they now occupy.

He is well known all over the northwestern part of the state for his write-ups of locally known people and description of early days when Oklahoma was still Indian territory. For many years he traveled about the countryside in the interest of newspapers both here and in Alfalfa county, as well as some parts of Kansas.

Mr. Strickland is a native of Missouri. He was instrumental in perfecting the organization of some 200 persons known as the annual Missouri picnic, and now holds the presidency of that group. He has been active until a few years ago in the different farmers' organizations of Alva. On March 14 Mr. Strickland will celebrate his seventy-sixth birthday anniversary.

OBITUARY

[Editor's Note: The first part of this obituary was written by I. T. Strickland himself prior to his death on February 28. Mr. Strickland wrote this on November 3, 1926. He died February 28, 1935.]

Isaac Thomas Strickland was born 8 miles south of Osceola, Mo., by honest but humble parents on March 14, 1859. My mother's name was Narcissus Adaline Lessley and was born in Stoddard county, Mo. My father's name was John T. Strickland, who was born July 5, 1828, in the state of Georgia (Gwinnett Co.) and when only six months old moved with his parents to Henderson county, Tennessee, and remained there until March 10, 1846, when with his only whole brother, Isaac Strickland, he moved to St. Clair county, Mo., about 10 miles south of Osceola when that country was new. My father was a school teacher of a good many terms experience. I lived there and grew to manhood and was married to Sarah Ellen Hutton, who was born in St. Clair county, on August 7, 1881. To this union were born seven children in the order named: Bertie Linton, Cora May, Ethel Maude, Joseph Claude, Benjamin Ward, Bessie Adaline and Homer Lee. I sold out in the fall of '86 and moved to Barber county, Kansas, and stayed there about a month and went on to Nomansland and located above Beaver city at Boyd city. Stayed there two years and moved back to Barber county, Kans., and when the Cherokee strip opened to settlement I made the run and secured a claim seven and a half miles east of Alva, coming down from Kiowa in one hour and ten minutes and am still on my homestead. On March 29, 1903, I was married to Miss Ottie E. Arndt and to this union was born in the order named: Flossie Irene, Girty Very, Rex Arndt and Thomas Leo.

He died in his home in Alva February 28, 1935, age 75 years 11 months and 14 days. He was converted during the revival here in the Ashley United Brethren church by Rev. G. M. Beitz. He and two of his daughters, Flossie Irene and Girty Vera, were baptized and united with the United Brethren church at that time. A daughter, Ethel Maude, and a son, Bertie Linton, preceded him in death. He was faithful in his attendance at all church services and was always interested in and took a leading part in all choir work. He was Sunday school superintendent for several years.

He leaves to mourn their loss: his wife, Ottie E., five sons, four daughters, 18 grandchildren, 2 great-grandchildren, two sisters, Mrs. Ollie Culbertson of Kansas City and Mrs. E. E. Morris of El Campo, Texas, besides a host of relatives and innumerable friends.

JOHN STRICKLAND ON 1820 CENSUS OF
HARDIN COUNTY, TENNESSEE, MISPLACED IN INDEXES

There is a JOHN STRICKLAND who resided in Hardin County, Tennessee in 1820, who may have been overlooked by researchers interested in that area, as he does not appear as such in two of the indices for that census. (He appears as JOHN STUCKLAND in the Elizabeth P. Bentley 1981 index from Genealogical Publishing Company, and at an unknown location in Accelerated Indexing Systems 1974 index.)

JOHN's household is on the page preceding the listing for WILLIAM STRICKLIN, eight households away. The demographics of the two households are identical, each with one male at least 16 years of age but not yet 26, a female of the same age bracket, and each with a boy and girl under the age of 10 years.

From the names of the neighbors, including ISHAM CHERRY, ELI CHERRY, EUWALL(?) ROGERS, THOMAS BROOKS and BAILEY BROOKS, CALEB SULLIVAN, JOHN WHITE, et al., it would appear that this was the same Horse Creek neighborhood ("Big Ivy") where parts of the STRICKLAND/LIN family have continued to reside to this day.

ISHAM CHERRY's name appears as a witness to the 8 September 1827 will of MARY RICHARDSON, in which she refers to her daughter MILLY STRICKLIN and granddaughter MARY STRICKLIN, which will was recorded in Hardin County 2 October 1828.

CENTERFOLD: "THE COUNTIE WESTMORLAND AND KENDALE THE CHEIF TOWNE DESCRIBED"

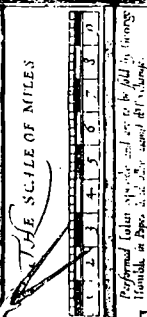
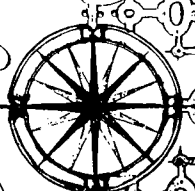
This is a reduced copy made for Strickland Scene directly from the original map by JOHN SPEED, from the extremely rare Latin edition (1616) of his atlas, the Theatre of Great Britain. The map was designed and engraved in Amsterdam by JODOCUS HONDIUS, the leading Dutch mapmaker of the time. The town of Kendal is located at the lower left of center of the map, with Sizergh below it. Note "STRICKLAND Gate" listed at letter "D" in the table to the right of the detailed plan of Kendal in the upper left corner. It appears that the reference "D" was omitted from the detailed inset, but it is likely that it should have been in the vicinity of letters "C" and "E" that do appear.

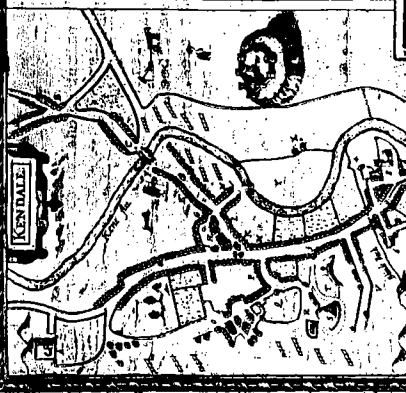


PART OF WESTMORLAND

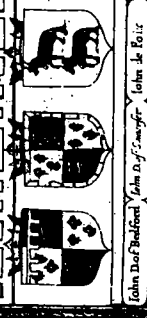



SIGNATURE OF SYLVESTER STRICKLAND OF FRANKLIN COUNTY, MAINE



The above signature, dated 7 April 1818 at Wilton, Kennebec County, Maine, is apparently that of SYLVESTER STRICKLAND, the only 1820 census index Strickland entry for that county. This portion of Kennebec County later fell within the boundaries of Franklin County when it was created. The signature is on a document in the Revolutionary War pension file W. 22,096 of JOHN ROACH of Wilton, certifying ROACH's need for government assistance.

REFERENCES TO LOWER NORFOLK COUNTY, VIRGINIA STRICKLANDS
IN THE YEAR 1655

On the following page is a copy of an item dated February 14, 1655, whereby MARY STRICKLAND of Lower Norfolk County, Virginia, registered the earmark of one browne Cowe. The item is found on page 203 of Norfolk County Wills & Deeds Book C, 1651-1656. Proper transcription requires a greater knowledge of seventeenth century script; the following was submitted as a stopgap offering until a more knowledgeable submittal might be made:

"The Mark of one browne Cowe belonging unto Windefar Mary [??] is Cropt of both eares under Rield [??] in ye right Ear, & slitt in ye left ear - the ork [??] Cowe being given hir by mire [??] hir mother, J. D i ? [??] it may be recorded in Court as witness my hand this : 14th feb -
